This email is to confirm that at the Legislative Hearing on Tuesday, April 4 for the appealed Special Tax Assessment for property at 1162 BLAIR AVENUE. (File No. J2306B, Assessment No. 238105), the Hearing Officer has reviewed the situation and discussed with St. Paul Police Department and although unfortunate you didn't have an exact bill at the time of the event, St. Paul Police priority is to secure the scene, and therefore her recommendation is that the City Council approve the assessment.
