She has come around to support it. One of the things she has been saying, she really believes the schools need to be partnering with the Council in the process. On this item, the school did come up with a solution for traffic in front of their school without relying on the City, so it was not deprioritizing any of the other schools. It did not qualify under the conduit bonds. It was privately fundraised to fund the project. She will vote in support of this. It needs 5 votes. We got some information from the school.*

*Councilmember Thao recognized Brendmoen's thoughtful due diligence in looking at this. This skyway is for the safety of the kids. They are not using City dollars. They are finding private dollars. If they are willing to take the initiative to do this, that is good for the City, the infrastructure, and the school.*

*Councilmember Noecker concurred with Thao. We should be cautious about government overreach. We don't really get to tell private property owners what to do. This is privately funded and in our code.*

*Councilmember Prince said she had voted against this item last week because she voted against the conduit bond issue in an effort to be consistent. She is more inclined to vote for it because it is not part of the conduit bond process. She will vote in support of the vacation.*

*Councilmember Noecker thanked Brendmoen for her leadership.*

*Councilmember Prince concurred with Brendmoen and Noecker said. She gave Tolbert credit for the weekly meetings he held to go over the budget.*

*Councilmember Jalali said she has been quiet and holding in a lot of emotions. She respects that they all made difficult choices. The Council shows little movement about police funding. She struggles to understand this. This is a department over \$120 Million. Advocates for Police funding and fear mongering make the case that SPPD is not effective for preventing crime. There have been \$2.6 Million in settlements. Let's have less officers period. The status quo is not good for our community.*

*Councilmember Yang said will there be comments on the next item. Brendmoen responded we are taking the public hearing as a combined report.*

*Councilmember Yang said a lot of effort was put into the budget. The councilmembers did what they can. She is celebrating a lot of what was accomplished this year. The Safe ordinance, making sure we are allocating money for that, celebrating the wins that there will not be a police academy in this upcoming year. While there are things to celebrate, we are so under serving.*

*Councilmember Thao said to the friends and neighbors, from what he can see, this is a realistic and solid budget, this has been more challenging. Proud of this year's budget to continue to fund things. They are restoring Library hours.*

*Noecker thanked Yang and Jalali for their words. In voting for this budget, she is not supporting the status quo. She is supporting the plan the Mayor lays out. If there is an alternative budget proposal, she is happy to consider it.*

*Brendmoen said this budget takes a lot of work and you have to push your sleeves up along the way.*

*Prince acknowledged Yang and Jalali. The Mayor cut under \$1 Million from Police. The Police budget in Saint Paul has budget for attrition, and this year it is \$3.7 Million. People have to resign or retire in 2021 before another police office can be hired. They*



*got more on this budget than they realized.*

*Councilmember Tolbert thanked Brendmoen and the Mayor. Toughest budget he had to work on in his 9 years at the Council because it is the first with a zero percent levy increase. Every single department had to be looked at. Police was \$105 Million last year. Now it is \$101 Million. They did a zero percent levy increase. People and businesses are hurting. Asking more money from our residents would have been hard to do. There will be a lot of changes.*

*Marcia Moermond, Legislative Hearing Officer, said the appellant looked at things differently and submitted a letter. There was also a voice mail transcribed and added today. This story has 2 chapters. Chapter 2 is in front of you. This is a registered vacant building. Chapter 1 happened in September and October when the fire certificate of occupancy was revoked. That was appealed and an extension granted. The owner developed a work plan. He bought the property mid-June. The previous owner did not disclose there was an order out there. There was a TISH (Truth In Sale of Housing) report. The owner bought the house to empty it, rehab it, and have it reoccupied. He did not believe he would be able to execute the repairs. The tenants ended up moving out. When November 2 came, the appellant was a no show for the inspection. The inspector said there was no compliance to the orders and the units seemed vacated so it was referred to the vacant building program. The appeal today is about that program. The owner did say it was empty and thinks it should only be subject to the orders for reinstating the fire certificate of occupancy. City says once you get to this point, you need to do a code compliance. What is the measure used before the property can be reoccupied? We have violations that meet the definition of the Legislative Code. It talks about unoccupied and multiple building violations. Property main, fire, mechanical, plumbing and electrical code violations. There are a lot of permits that need to be pulled. The owner was also communicating that he just purchased the property, he should have had more time, and the previous owner had not been held to the same standard. The last certificate of occupancy was issued in 2012 and it was determined to be a Class A property. It went from being a Class A to a Class D property. Additionally, he argued that COVID made it difficult if not*

*impossible for him to do the necessary repairs. He did mention that he was frustrated that his hearing for November 17 had to be rescheduled. It was scheduled for 2:30 on that day, and it was rescheduled because of a court issue. He did have a one week wait. He became a victim of circumstances and this communication. I don't think that is the situation in this case. She talked to Yang about this earlier. She recommend the Council deny the appeal. This should be a Category 2 vacant building and waive the fee for 90 days.*

*Councilmember Yang asked was the owner referred to the rental rehab program. Moermond responded that usually we made that kind of referral. He did not mention financing would be a program. Rather, it was logistics. He had the money set aside and ready to spend it.*

*Councilmember Yang mentioned their statement of not being able to maintain their home. She asked if other owners have been able to maintain their home. Moermond responded said this is a rental property. What would be in play would be the tenant's willingness to allow access to the property, contractors in to do the work, and doing scheduling to respect everyone's safety. We have consistently seen that repairs can get done and issues addressed. Most certainly, COVID has had an impact of people doing repairs. It was the landlord's perspective that the work needed to have the rooms emptied. He didn't think he could sheetrock while having someone living in it. Repair, yes. Totally rehabbing it, that is different. There was an elderly woman in there. She felt uncomfortable and did end up leaving.*

*Yang asked did she need time to verify. Moermond responded we can provide that information that he is aware of the rental rehab program.*

*Council President Brendmoen said the kind of disrepair is rotted wood that did not happen during COVID. She would be in support of the recommendation of the Legislative Hearing Officer. It puts the property in a Category 2 certificate of occupancy. It focuses money on the repairs. There is a lot of repair there.*

*Brendmoen asked are we concerned about the recommendation? Should we lay it over? Prince responded she is concerned that the tenants had to vacate during the eviction moratorium. This raises a red flag.*

*Brendmoen asked do we want to lay it over.*

*Moermond said he testified he came to arrangements with the tenants that they would leave and he would not pursue anything with nonpayment of rent. An order to vacate related to the revocation, it would be referred to the vacant building program. The City is not going in for administration purposes and having people leave. Prince responded thank you.*

*Yang stated she does not need a layover. Her only ask is to reconnect to the property owner about the program. Moermond responded they will get that information out in the morning.*

*Yang moved the recommendation of the Legislative Hearing Officer.*
