**Event:** Kellogg Craft Beer Overlook Event, September 2016

**Description of Variance:**

**Locations:** Event will be located outdoors at Kellogg Park, between Wabasha and Robert at the intersection of Cedar and Kellogg Boulevard

**Noise Source:** Brian Horst and Music in Mears LLC has applied for a sound level variance, at a requested sound level limit of 80 dBA at no specified distance, in order to provide music outdoors at the Kellogg Park at Kellogg Boulevard and Cedar Street on Fridays, September 16, 23, and 30, 2016, from 3:00 p.m. until 7:00 p.m., with a pre-event sound check from 2:30 p.m. until 3:00 p.m. for the Kellogg Craft Beer Overlook Event. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 3:00 p.m. until 7:00 p.m., with a pre-event sound check from 2:30 p.m. until 3:00 p.m. on September 16, 23, and 30, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured at 50 feet from the sound source from 3:00 p.m. until 7:00 p.m. on September 16, 23, and 30, 2016. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 7:00 p.m. on the dates of the event.

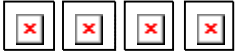
