This is to confirm that Legislative Hearing officer Marcia Moermond reviewed and approved the documents submitted to her for review; therefore, she is going to amend the resolution on April 1, 2020 at the 3:30 p.m. City Council Public Hearing to grant 180 days for the removal or repair of the structure in the above matter.

At the conclusion of the 180-day grant of time, the Council will receive a report from the Legislative Hearing Officer with findings on the status of the substantial abatement and a Legislative Hearing is scheduled for **October 13, 2020 at 10:00 AM in Room 330 City Hall** at which owners, interested parties and Department of Safety and Inspection staff will present information on the current building conditions and progress toward abatement of the dangerous/nuisance conditions and the resulting findings will be presented to the City Council at a public hearing on **Wednesday, October 28, 2020** at 3:30 p.m. in Room 300 City Hall for its consideration.
