BOND RESOLUTION OF THE PORT AUTHORITY OF THE CITY OF SAINT PAUL

WHEREAS, in accordance with the provisions of Minnesota Statutes, Section 469.060 and applicable provisions of Minnesota Statutes, Chapter 475 (together, the "Act") the Port Authority of the City of Saint Paul, Minnesota (the "Port Authority") is permitted upon authorization by the City Council of the City of Saint Paul, Minnesota (the "City") to issue general obligation bonds whereby the Port Authority levies a tax and pledges the general obligation of the City to the repayment of such general obligation bonds in order to (i) secure funds needed by the Port Authority to pay for development costs, or (2) pay for other purposes set forth in Minnesota Statutes, Sections 469.048 to 469.068, as amended (the "Port Authority Act"); and

WHEREAS, by an Ordinance to be adopted by the City Council on November 9, 2016 and approved by the Mayor (the "Authorizing Ordinance") the City Council, among other things, authorized the Port Authority to issue its general obligation bonds, in one or more series of taxable or tax-exempt obligation, in an aggregate principal amount not to exceed \$6,300,000 for the purposes described below and further approved the Port Authority's pledge of the City's full faith and credit and resources as security for the payment of debt service such bonds; and

WHEREAS, the Port Authority previously issued its General Obligation Bonds, Series 2008-6 (the "Prior Bonds"), in the original aggregate principal amount of \$8,130,000, the proceeds of which were used by the Port Authority to finance the acquisition and redevelopment of the property known as the 3M St. Paul Campus located in the area of Phalen Boulevard, Arcade Street and Forest Street, and East Seventh Street, in St. Paul, Minnesota; and

WHEREAS, the Port Authority desires to issue and sell, with the advice of PFM Financial Advisors LLC (formerly known as Public Financial Management, Inc.) (the "Municipal Advisor") the following obligations: (i) the Tax-Exempt General Obligation Refunding Bonds, Series 2016-3 (the "Series 2016-3 Bonds"); and (ii) Taxable General Obligation Bonds, Series 2016-4 (the "Series 2016-4 Bonds" and together with the Series 2016-3 Bonds, the "Series 2016 Bonds"); and

WHEREAS, the Series 2016 Bonds will be sold in principal amounts such that the combined total aggregate principal amount will not exceed \$6,300,000 for the purposes of: (i) advance refunding the outstanding Prior Bonds, (ii) financing additional development costs of the Port Authority as authorized under the terms of the Port Authority Act, and (iii) paying costs of issuance of the Series 2016 Bonds; and

WHEREAS, pursuant to the Authorizing Ordinance, the City authorized a Pricing Committee, comprised of the persons described therein, to determine certain terms of the Series 2016 Bonds as hereinafter described.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Port Authority of the City of Saint Paul, Minnesota, as follows:

Section 1. Sale of the Series 2016 Bonds.

1.01. <u>Purpose of the Series 2016 Bonds</u>. The Port Authority is proposing to issue the Series 2016 Bonds authorized by the Authorizing Ordinance, pursuant to the Act, in the combined original aggregate principal amount not to exceed a par amount of \$6,300,000, in order to: (i) advance refund the outstanding Prior Bonds, (ii) finance additional development costs of the Port Authority as authorized under the terms of the Port Authority Act, and (iii) pay costs of issuance of the Series 2016 Bonds.

- 1.02. <u>Requirements of the Act.</u> The Port Authority has complied with or will comply with the provisions of the Act and the Authorizing Ordinance.
- Pricing Committee. The Pricing Committee created by the Authorizing Ordinance, and consisting of a representative from the Port Authority, the City's Director, Office of Financial Services and Debt Manager representing the City's Office of Financial Services, and a representative of the Municipal Advisor (the "Pricing Committee"), is hereby delegated the authority to determine the final pricing of the Series 2016 Bonds and for the Port Authority to enter into one or more Bond Purchase Agreements or Bid Forms, to be dated the date of the purchase of the Series 2016 Bonds (the "Bond Purchase Agreement") with the winning bidder of each series of the Series 2016 Bonds. The Pricing Committee is hereby delegated the authority to establish the terms and conditions of each series of the Series 2016 Bonds, subject to the limitations set forth in this Resolution. In addition, the Pricing Committee is hereby authorized to establish the annual amount of the tax levy to be certified to the Auditor with respect to each series of the Series 2016 Bonds. The expected tax levy for the Series 2016 Bonds is not expected to exceed the tax levy for the Prior Bonds in any calendar year while the Series 2016 Bonds are outstanding. The Series 2016 Bond terms, amendments, if any, and tax levy, as set forth in the completed certificate of the Pricing Committee shall, upon delivery, be deemed to be a part of this Resolution as if set forth originally herein and such terms shall be incorporated and included in the form of the Series 2016 Bonds and in such other certificates, documents and agreements as appropriate.

The final decision of the Pricing Committee to execute and deliver the Bond Purchase Agreement on behalf of the Port Authority shall be controlling. The Pricing Committee, in its discretion on behalf of the Port Authority, may waive non-substantive informalities with respect to the proposals to purchase the Series 2016 Bonds. The Pricing Committee is hereby authorized to determine the maturity dates, principal amounts of the stated maturities of the Series 2016 Bonds, optional and mandatory redemption provisions with respect to the Series 2016 Bonds, and such other terms of the Series 2016 Bonds, as the Pricing Committee deems most appropriate and in the best interests of the Port Authority, provided (i) the true-interest cost for the Series 2016 Bonds shall not exceed 4% per annum and a minimum net present value savings as a percentage of refunded debt service of not less than 7% with respect to the Prior Bonds, (ii) the final maturity date of the Series 2016 Bonds shall be no later than February 1, 2029, and (iii) the original aggregate principal amount of the Series 2016 Bonds shall not exceed \$6,300,000.

- 1.04. <u>Execution of Purchase Agreement</u>. The President and Chief Financial Officer of the Port Authority, or their designee, are directed to execute and deliver each Bond Purchase Agreement with the winning bidders of each series of the Series 2016 Bonds.
- 1.05. General Terms of the Series 2016 Bonds. The Series 2016 Bonds will be dated as of their date of issuance or shall be dated such other date as the Pricing Committee may determine in denominations of \$5,000 or any integral multiple thereof, and each series shall be numbered from R-1 upwards in order of issuance, or with such other numbering and in such other order as the Pricing Committee may determine. The issuance, sale and delivery of the Series 2016 Bonds pursuant to the Act is hereby approved by the Port Authority.

1.06. Redemption.

(a) Optional Redemption. The Series 2016-3 Bonds shall be subject to optional redemption at the dates and prices set forth in the Certificate of Pricing Committee delivered in accordance with this Resolution. Optional redemptions of the Series 2016-3 Bonds may be in whole or in part and if in part at the option of the Port Authority and in such manner as the Port Authority shall determine. If less than all Series 2016-3 Bonds of a maturity are called for redemption, the Port Authority will notify DTC (as defined herein) of the particular amount of such maturity to be prepaid. DTC will determine by lot the

amount of each participant's interest in such maturity to be redeemed and each participant will then select by lot the beneficial ownership interests in such maturity to be redeemed. All optional redemptions of the Series 2016-3 Bonds shall be at a price of par plus accrued interest to the redemption date.

The Series 2016-4 Bonds are not subject to optional redemption.

- (b) <u>No Scheduled Mandatory Redemption</u>. There are no Term Bonds which are subject to mandatory redemption and prepayment on scheduled dates, unless determined to be advantageous by the Pricing Committee.
- (c) <u>Selection of Series 2016-3 Bonds to be Redeemed; Redemption Procedure</u>. In the event any of the Series 2016-3 Bonds are called for redemption, notice thereof identifying the Series 2016-3 Bonds to be redeemed shall be given by the Registrar (as defined herein) by mailing a copy of the redemption notice by first class mail (postage prepaid) to the registered owner of each Series 2016-3 Bond to be redeemed at the address shown on the registration books kept by the Registrar and by publishing the notice if required by law. Failure to give notice by publication or by mail to any registered owner, or any defect therein, shall not affect the validity of the proceedings for the redemption of Series 2016-3 Bonds. Series 2016-3 Bonds so called for redemption shall cease to bear interest after the specified redemption date, provided that the funds for the redemption are on deposit with the Registrar at that time.
- (d) <u>Notice of Redemption</u>. The Registrar shall call the Series 2016-3 Bonds for optional redemption and prepayment as herein provided upon written receipt by the Registrar at least forty-five (45) days prior to the redemption date of a request of the Port Authority. Such request shall specify the series and principal amount of Series 2016-3 Bonds to be called for redemption and the redemption date.

Mailed notice of optional redemption shall be given to the Paying Agent (as defined below) and to each affected Holder. If and when the Port Authority shall call any of the Series 2016-3 Bonds for redemption and prepayment prior to the stated maturity thereof, the Registrar shall give written notice in the name of the Port Authority of its intention to redeem and pay such Series 2016-3 Bonds at the office of the Registrar. Notice of redemption shall be given by first class mail, postage prepaid, mailed not less than thirty (30) days prior to the redemption date, to each Holder of Series 2016-3 Bonds to be redeemed, at the address appearing in the Bond Register. All notices of optional redemption shall state: (i) the redemption date; (ii) the redemption price; (iii) if less than all outstanding Series 2016-3 Bonds are to be redeemed, the identification (and, in the case of partial redemption, the respective principal amounts) of the Series 2016-3 Bonds to be redeemed; (iv) that on the optional redemption date, the redemption price will become due and payable upon each such Series 2016-3 Bond, and that interest thereon shall cease to accrue from and after said date; (v) the place where such Series 2016-3 Bonds are to be surrendered for payment of the redemption price (which shall be the office of the Registrar); and (vi) include a statement that the redemption so noticed is conditioned on sufficient funds being held by the Port Authority on or before noon on the applicable redemption date to pay the full redemption price, and if at such time the amount so held is not sufficient to pay all amounts required to effect the noticed redemption in full, the redemption shall be cancelled, with all Series 2016-3 Bonds tendered for such redemption being returned to the holders thereof and no liability on the part of the Port Authority shall arise as a result of such cancellation.

Notices to DTC or its nominee shall contain the CUSIP numbers of the Series 2016-3 Bonds. If there are any Holders of the Series 2016-3 Bonds other than DTC or its nominee, the Registrar shall use its best efforts to deliver any such notice to DTC on the business day next preceding the date of mailing of such notice to all other Holders.

Section 2. Registration and Payment.

- 2.01. <u>Registered Form.</u> The Series 2016 Bonds will be issued only in fully registered form. The interest thereon and, upon surrender of each Series 2016 Bond, the principal amount thereof, is payable by check or draft issued by the Registrar.
- 2.02. Dates; Interest Payment Dates. Each Series 2016 Bond shall be dated as of the last interest payment date preceding the date of authentication to which interest on the Series 2016 Bonds has been paid or made available for payment, unless: (i) the date of authentication is an interest payment date to which interest has been paid or made available for payment, in which case the Series 2016 Bonds will be dated as of the date of authentication; or (ii) the date of authentication is prior to the first interest payment date, in which case the Series 2016 Bonds will be dated as of the date of original issue. The Series 2016 Bonds shall mature on such dates and in such principal amounts as indicated in the Certificate of Pricing Committee. The Series 2016 Bonds shall bear interest at the rates per annum as indicated in the Certificate of Pricing Committee and shall be payable on each February 1 and August 1, commencing on February 1, 2017, computed on the basis of a 360-day year of twelve thirty-day months. The interest on the Series 2016 Bonds is payable to the registered owners of record thereof as of the close of business on the fifteenth (15th) day of the immediately preceding month, whether or not such day is a business day.
- 2.03. Registrar. The Chief Financial Officer of the Port Authority is hereby authorized to appoint a bank or trust company (or officer of the Port Authority) to act as paying agent, bond registrar and transfer agent with respect to the Series 2016 Bonds (the "Registrar" or "Paying Agent"). The Port Authority hereby names U.S. Bank National Association as the initial Registrar and Paying Agent. Such Registrar shall so act for all Series 2016 Bonds unless and until a successor Registrar is duly appointed. Such appointment and designation shall be made by certificate delivered by the Chief Financial Officer upon delivery of the Series 2016 Bonds to the initial purchaser. A successor Registrar shall be a bank or trust company eligible for designation as bond registrar pursuant to the Act, and may be appointed pursuant to any contract the Port Authority and such successor Registrar shall execute which is consistent herewith. The Registrar shall also serve as Paying Agent unless and until a successor Paying Agent is duly appointed. Principal and interest on the Series 2016 Bonds shall be paid to the registered holder or holders of the Series 2016 Bonds (the "Holder" or "Holders") in the manner set forth in the form of the Series 2016 Bonds. The effect of registration and the rights and duties of the Port Authority and the Registrar with respect thereto are as follows:
 - (a) *Register*. The Registrar shall keep a bond register in which the Registrar provides for the registration of ownership of the Series 2016 Bonds and the registration of transfers and exchanges of the Series 2016 Bonds entitled to be registered, transferred, or exchanged.
 - (b) Transfer of Series 2016 Bonds. Upon surrender for transfer of a Series 2016 Bond duly endorsed by the registered owner thereof or accompanied by a written instrument of transfer, in form satisfactory to the Registrar, duly executed by the registered owner thereof or by an attorney duly authorized by the registered owner in writing, the Registrar shall authenticate and deliver, in the name of the designated transferee or transferees, one or more new Series 2016 Bonds of a like aggregate principal amount and maturity, as requested by the transferor. The Registrar may, however, close the books for registration of any transfer after the fifteenth (15th) day of the month preceding each interest payment date and until that interest payment date.
 - (c) Exchange of Series 2016 Bonds. When Series 2016 Bonds are surrendered by the registered owner for exchange, the Registrar shall authenticate and deliver one or more new

Series 2016 Bonds of a like aggregate principal amount and maturity as requested by the registered owner or the owner's attorney in writing.

- (d) *Cancellation*. Series 2016 Bonds surrendered upon transfer or exchange shall be promptly cancelled by the Registrar and thereafter disposed of as directed by the Port Authority.
- (e) Improper or Unauthorized Transfer. When a Series 2016 Bond is presented to the Registrar for transfer, the Registrar may refuse to transfer the Series 2016 Bond until the Registrar is satisfied that the endorsement on the Series 2016 Bond or separate instrument of transfer is valid and genuine and that the requested transfer is legally authorized. The Registrar shall incur no liability for the refusal, in good faith, to make transfers which it, in its judgment, deems improper or unauthorized.
- (f) Persons Deemed Owners. The Port Authority and the Registrar may treat the person in whose name a Series 2016 Bond is registered in the bond register as the absolute owner of the Series 2016 Bond, whether the Series 2016 Bond is overdue or not, for the purpose of receiving payment of, or on account of, the principal of and interest on the Series 2016 Bond and for all other purposes, and payments so made to a registered owner or upon the owner's order shall be valid and effectual to satisfy and discharge the liability upon the Series 2016 Bond to the extent of the sum or sums so paid.
- (g) Taxes, Fees, and Charges. The Registrar may impose a charge upon the owner thereof for a transfer or exchange of Series 2016 Bond sufficient to reimburse the Registrar for any tax, fee, or other governmental charge required to be paid with respect to the transfer or exchange.
- (h) *Mutilated, Lost, Stolen or Destroyed Series 2016 Bond*. If a Series 2016 Bond becomes mutilated or is destroyed, stolen, or lost, the Registrar shall deliver a new Series 2016 Bond of like amount, number, maturity date, and tenor in exchange and substitution for and upon cancellation of the mutilated Series 2016 Bond or in lieu of and in substitution for any Series 2016 Bond destroyed, stolen, or lost, upon the payment of the reasonable expenses and charges of the Registrar in connection therewith; and, in the case of a Series 2016 Bond destroyed, stolen, or lost, upon filing with the Registrar of evidence satisfactory to it that the Series 2016 Bond was destroyed, stolen, or lost, and of the ownership thereof, and upon furnishing to the Registrar an appropriate bond or indemnity in form, substance, and amount satisfactory to it and as provided by law, in which both the Port Authority and the Registrar must be named as obligees. Series 2016 Bonds so surrendered to the Registrar shall be cancelled by the Registrar and evidence of such cancellation shall be given to the City. If the mutilated, destroyed, stolen, or lost Series 2016 Bond has already matured or been called for redemption in accordance with its terms, it is not necessary to issue a new Series 2016 Bond prior to payment.
- 2.04. Execution, Authentication and Delivery. The Series 2016 Bonds shall be prepared under the direction of the Pricing Committee, provided that all signatures may be printed, engraved, or lithographed facsimiles of the originals. The Series 2016 Bonds are hereby authorized to be executed by the Chair and Secretary of the Port Authority, or their designee. If an officer whose signature or a facsimile of whose signature appears on the Series 2016 Bonds ceases to be such officer before the delivery of any Series 2016 Bond, that signature or facsimile shall nevertheless be valid and sufficient for all purposes, the same as if the officer had remained in office until delivery. Notwithstanding such execution, a Series 2016 Bond shall not be valid or obligatory for any purpose or entitled to any security or benefit under this Resolution unless and until a certificate of authentication on the Series 2016 Bond has been duly executed by the manual signature of an authorized representative of the Registrar.

Certificates of authentication on different Series 2016 Bonds need not be signed by the same representative. The executed certificate of authentication on a Series 2016 Bond is conclusive evidence that it has been authenticated and delivered under this Resolution. When the Series 2016 Bonds have been so prepared, executed, and authenticated, the Port Authority shall deliver the same to the initial purchaser upon payment of the purchase price in accordance with the Bond Purchase Agreement heretofore made and executed, and the initial purchaser is not obligated to see to the application of the purchase price.

2.05. <u>Temporary Series 2016 Bonds</u>. The Port Authority may elect to deliver, in lieu of printed definitive Series 2016 Bonds, one or more typewritten temporary Series 2016 Bonds in substantially the form set forth in EXHIBIT A with such changes as may be necessary to reflect more than one maturity in a single temporary bond. Upon the execution and delivery of definitive Series 2016 Bonds, the temporary Series 2016 Bonds shall be exchanged therefor and cancelled.

Section 3. Form of the Series 2016 Bonds.

- 3.01. Printing of Series 2016 Bonds. All of the provisions of the Series 2016 Bonds, when executed as authorized herein, shall be deemed to be a part of this Resolution as fully and to the same extent as if incorporated verbatim herein and shall be in full force and effect from the date of execution and delivery thereof. The Series 2016 Bonds shall be substantially in the form attached to this Resolution as EXHIBIT A, which form is hereby approved, with such necessary and appropriate variations, omissions and insertions (including changes to the aggregate principal amount of each series of the Series 2016 Bonds, the stated maturities of the Series 2016 Bonds, the interest rates on the Series 2016 Bonds, the terms of redemption of the Series 2016 Bonds, and variation from Port Authority policies regarding methods of offering general obligation bonds) as the Pricing Committee, in their discretion, shall determine. The execution of the Series 2016 Bonds with the manual or facsimile signatures of the Chair and Secretary, or their proper designees, and the delivery of the Series 2016 Bonds by the Port Authority shall be conclusive evidence of such determination.
- 3.02. <u>Approving Legal Opinion</u>. The Secretary is authorized and directed to obtain a copy of the proposed approving legal opinion of Barnes & Thornburg LLP, as Bond Counsel, which shall be complete except as to dating thereof and cause the opinion to accompany each Series 2016 Bond.

Section 4. Payment; Security; Pledges and Covenants.

4.01. Bond Funds.

- (a) <u>Debt Service Fund</u>. A "General Obligation Refunding Bonds, Series 2016 Debt Service Fund" (the "Debt Service Fund") is hereby created, with the following subaccounts: (i) the Series 2016-3 Debt Service Fund Subaccount, and (ii) the Series 2016-4 Debt Service Fund Subaccount. The proceeds of the ad valorem taxes hereinafter levied as described in this Resolution, are hereby pledged to the Series 2016-3 Debt Service Fund Subaccount and the Series 2016-4 Debt Service Fund Subaccount. If a payment of principal or interest on the Series 2016-3 Bonds or the Series 2016-4 Bonds becomes due when there is not sufficient money in the Series 2016-3 Debt Service Fund Subaccount or the Series 2016-4 Debt Service Fund Subaccount, as applicable, to pay the same, the Port Authority and the City will pay such principal or interest from the general fund of the City, and the general fund will be reimbursed for those advances out of the proceeds of the taxes levied by the Port Authority, without limitation as to rate or amount, by this Resolution, when collected.
- (b) <u>Series 2008-6 Escrow Fund</u>. There is hereby created a special account to be designated as the "Series 2008-6 Escrow Fund" (the "Escrow Fund"), to be held and administered as a separate

account with U.S. Bank National Association, as escrow agent (the "Escrow Agent") pursuant to the terms of the Escrow Agreement (as defined herein). The Port Authority will deposit from proceeds of the Series 2016-3 Bonds and any funds currently on hand in the Debt Service Fund attributable to the Prior Bonds, in amounts to be determined by the Pricing Committee, into the Escrow Fund with the Escrow Agent for the defeasance of the Prior Bonds. Amounts on deposit in the Escrow Fund will be used by the Port Authority to fund the escrow for the redemption and prepayment of the Prior Bonds on an advance refunding basis. The Escrow Fund shall retain all investment earnings thereon. The Escrow Fund will be invested in federal securities maturing or callable at the option of the holder on such dates and bearing interest at such rates as will be required to provide sufficient funds, together with any cash or other funds retained in the Escrow Fund to pay (i) principal and interest on the Prior Bonds to and including February 1, 2018 (the "Prior Bonds Redemption Date"), and (ii) the principal amount of the February 1, 2018 through February 1, 2029 maturities of the Prior Bonds on the Prior Bonds Redemption Date. The Escrow Fund will be irrevocably appropriated to the payment of the principal of and interest on the Prior Bonds until the proceeds of the Series 2016-3 Bonds therein are applied to prepayment of the Prior Bonds. The money in the Escrow Fund will be used solely for the purposes herein set forth and for no other purpose, except that any surplus in the Escrow Fund may be remitted to the Port Authority, all in accordance with the terms of the Escrow Agreement. In the event that the Escrow Agent notifies the Port Authority that there is any deficiency in the Escrow Fund, then the Port Authority shall promptly deposit funds necessary to cure such deficiency, but solely from amounts available from the Series 2016-3 Debt Service Fund Subaccount.

- (c) <u>Project Fund</u>. There is hereby created a special account to be designated as the "Series 2016-4 Project Fund" (the "Project Fund"), to be held and administered by the Port Authority separate and apart from all other funds of the Port Authority. Amounts on deposit in the Project Fund will be used solely to pay development costs authorized to be funded by the Port Authority under the terms of the Port Authority Act and to pay costs of issuance of the Series 2016 Bonds. When the identified future additional development costs are completed and the costs thereof paid, the Project Fund is to be closed and any remaining balance therein transferred to the Series 2016-4 Debt Service Fund Subaccount.
- (d) <u>Use of Proceeds</u>. On the date of issuance of the Series 2016 Bonds, the Port Authority shall:
 - (i) appropriate to the Escrow Fund the amount necessary to advance refund the Prior Bonds; and
 - (ii) deposit to the Project Fund the proceeds of the Series 2016-4 Bonds and the amount required to pay costs of issuance of the Series 2016 Bonds.
- (e) Arbitrage Restrictions. The money in the funds shall be used solely as provided herein, or to pay any rebate due to the United States. No portion of the proceeds of the Series 2016-3 Bonds shall be used directly or indirectly to acquire higher yielding investments or to replace funds which were used directly or indirectly to acquire higher yielding investments, except (i) for a reasonable temporary period until such proceeds are needed for the purpose for which the Series 2016-3 Bonds are issued, and (ii) in addition to the amounts referred to in clause (i) in an amount not greater than \$100,000. To this effect, any proceeds of the Series 2016-3 Bonds and any sums from time to time held in the Series 2016-3 Debt Service Fund Subaccount allocated to the Series 2016-3 Bonds (or any other account which will be used to pay principal or interest to become due on the Series 2016-3 Bonds) in excess of amounts which, under then applicable federal arbitrage regulations, may be invested without regard as to yield shall not be invested at a yield in excess of the applicable yield restrictions imposed by said arbitrage regulations on such investments after taking into account any applicable "temporary periods" or "minor portion" made available under the federal arbitrage regulations. In addition, the proceeds of the Series 2016-3 Bonds

and money allocated to the Series 2016-3 Bonds in the Series 2016-3 Debt Service Fund Subaccount shall not be invested in obligations or deposits issued by, guaranteed by, or insured by the United States of America, or any agency or instrumentality thereof, if and to the extent that such investment would cause the Series 2016-3 Bonds to be deemed to be "federally guaranteed" within the meaning of Section 149(b) of the Code.

- (f) <u>Allocation of Investment Earnings</u>. Investment earnings, net of rebatable arbitrage, shall be credited to the fund or account from which the investment was made.
- (g) Other Accounts and Subaccounts. The Port Authority is hereby authorized to create such accounts or subaccounts within the Project Fund and the Debt Service Fund (and accounts therein) to properly administer such funds and accounts and to assure compliance with the preceding paragraphs, and Section 6 hereof. Specifically, the Port Authority may create separate accounts and subaccounts to hold and apply the proceeds of the Series 2016 Bonds and revenues for the payment thereof.
- 4.02. <u>Escrow Agreement</u>. The President and Chief Financial Officer (or their proper designees) are hereby authorized to enter into an Escrow Agreement (the "Escrow Agreement") with the Escrow Agent, in order to establish an escrow account for the advance refunding of the Prior Bonds.

The Chief Financial Officer is also authorized to subscribe for State and Local Government Securities issued by the United States Treasury (SLGS) or bid the funding of the escrow account established hereunder and under the Escrow Agreement with eligible United States Treasury Bonds and Notes.

- 4.03. <u>Filing of Resolution</u>. The Secretary of the Port Authority is authorized and directed to file a certified copy of this Resolution, as well as an originally executed copy of the Pricing Committee's certificate, with the Auditor of Ramsey County, Minnesota (the "Auditor"), together with such other information as he or she shall require, and to obtain the Auditor's certificate that the Series 2016 Bonds have been entered in the Auditor's bond register, and that the tax levy required by law and this Resolution has been made.
- 4.04. <u>Pledge of Tax Levy</u>. For the purpose of paying the principal of and interest on the Series 2016 Bonds, and in accordance with the Authorizing Ordinance, and as required by Section 469.060 of the Act, there is hereby levied by the Port Authority a direct annual irrepealable ad valorem tax (the "Tax") upon all of the taxable property in the City, to be spread upon the tax rolls and collected with and as part of other general taxes of the City. The Tax will be credited to the Debt Service Fund and the applicable subaccounts in the Debt Service Fund in the amounts for each year calculated by the Pricing Committee and set forth the Certificate of the Pricing Committee
- 4.05. Overlevy Requirement. It is determined that the estimated collection of the foregoing Tax will produce at least five percent (5%) in excess of the amount needed to meet, when due, the principal and interest payments on the Series 2016 Bonds. The Tax so levied herein will be irrepealable until all of the Series 2016 Bonds are paid, provided that at the time the City makes its annual tax levies the City Clerk may certify to the Auditor (or the official of Ramsey County performing the functions of the Auditor) the amount available in the respective subaccount of the Debt Service Fund to pay principal and interest due during the ensuing year, and the Auditor will thereupon reduce the levy collectible during such year by the amount so certified.
- 4.06. <u>General Obligation Pledge</u>. If amounts on deposit in either of the subaccounts of the Debt Service Fund are not sufficient to pay principal and interest on the Series 2016-3 Bonds or the Series 2016-4 Bonds, as the same become due, the full faith and credit and taxing powers of the City shall be

and are hereby irrevocably pledged. If the balance in either of the subaccounts of the Debt Service Fund are ever insufficient to pay all principal and interest then due on the Series 2016-3 Bonds or the Series 2016-4 Bonds payable therefrom, the deficiency shall be promptly paid out of any other funds of the Port Authority and the City will pay such principal or interest from the general fund of the City, and the general fund will be reimbursed for those advances out of the proceeds of the taxes levied by the Port Authority, without limitation as to rate or amount, by this Resolution, when collected.

Section 5. Authentication of Transcript.

- 5.01. Furnishing of Documents. The officers of the Port Authority are authorized and directed to prepare and furnish to the initial purchaser and to Barnes & Thornburg LLP, as bond counsel to the Port Authority, certified copies of proceedings and records of the Port Authority relating to the Series 2016 Bonds and to the financial condition and affairs of the Port Authority and/or the City, and such other certificates, affidavits and transcripts as may be required to show the facts within their knowledge or as shown by the books and records in their custody and under their control, relating to the validity and marketability of the Series 2016 Bonds, and such instruments, including any heretofore furnished, will be deemed representations of the Port Authority as to the facts stated therein.
- 5.02. <u>Negotiated Sale</u>. The Port Authority has retained the Municipal Advisor as an independent financial advisor, and the Port Authority has heretofore determined, and hereby determines, to sell the Series 2016 Bonds by private negotiation, all as provided by Section 475.60, Subdivision 2(9) of the Act. The Series 2016 Bonds are hereby authorized to be sold to the initial purchasers subject to the requirements of this Resolution and the approval of the Pricing Committee.
- 5.03. Official Statement. There has been submitted to the Port Authority the form of the Preliminary Official Statement. The use and distribution of the Preliminary Official Statement and of a final Official Statement (collectively, the "Official Statement") in connection with the offer and sale of the Series 2016 Bonds is hereby approved. The President and Chief Financial Officer (or their proper designees) are authorized and directed to certify that they have examined the Official Statement, and that to the best of their knowledge and belief the Official Statement is a complete and accurate representation of the facts and representations made therein as of the date of the Official Statement and that the Official Statement will not, at the date of closing, and did not, as of its date, contain any untrue statement of a material fact or omit to state any material fact necessary in order to make the statements made therein, in the light of the circumstances under which they were made, not misleading.

Section 6. Tax Covenants.

- 6.01. <u>Tax-Exempt Series 2016-3 Bonds</u>. The Port Authority covenants and agrees with the holders from time to time of the Series 2016-3 Bonds that it will not take or permit to be taken by any of its officers, employees, or agents any action which would cause the interest on the Series 2016-3 Bonds to become includable in gross income for federal income tax purposes under the Internal Revenue Code of 1986, as amended (the "Code"), and the Treasury Regulations promulgated thereunder, in effect at the time of such actions, and that it will take or cause its officers, employees or agents to take, all affirmative action within its power that may be necessary to ensure that such interest will not become includable in gross income for federal income tax purposes under the Code and applicable Treasury Regulations, as presently existing or as hereafter amended and made applicable to the Series 2016-3 Bonds.
- 6.02. <u>Compliance with Code</u>. The Port Authority will comply with requirements necessary under the Code to establish and maintain the exclusion from gross income of the interest on the Series 2016-3 Bonds under Section 103 of the Code, including, without limitation, requirements relating

to temporary periods for investments and limitations on gross proceeds invested at a yield greater than the yield on the Series 2016-3 Bonds.

- 6.03. <u>Not Private Activity Bonds</u>. The Port Authority further covenants not to use the proceeds of the Series 2016-3 Bonds or to cause or permit them or any of them to be used, in such a manner as to cause the Series 2016-3 Bonds to be deemed to be "private activity bonds" within the meaning of Sections 103 and 141 through 150 of the Code.
- 6.04. <u>Procedural Requirements</u>. The Port Authority will use its best efforts to comply with any federal procedural requirements which may apply in order to effectuate the designations made by this section.

Section 7. <u>Book-Entry System; Limited Obligation of City.</u>

- 7.01. <u>DTC</u>. The Series 2016 Bonds will be initially issued in the form of a separate single typewritten or printed fully registered Series 2016 Bond for each of the maturities set forth in the certificate of the Pricing Committee. Upon initial issuance, the ownership of each Series 2016 Bond will be registered in the registration books kept by the Registrar in the name of Cede & Co., as nominee for The Depository Trust Company, New York, New York, and its successors and assigns ("DTC"). Except as provided in this section, all of the outstanding Series 2016 Bonds will be registered in the registration books kept by the Registrar in the name of Cede & Co., as nominee of DTC.
- Participants. With respect to Series 2016 Bonds registered in the registration books kept by the Registrar in the name of Cede & Co., as nominee of DTC, the Port Authority, the Registrar and the Paying Agent will have no responsibility or obligation to any broker dealers, banks and other financial institutions from time to time for which DTC holds Series 2016 Bonds as securities depository ("Participants") or to any other person on behalf of which a Participant holds an interest in the Series 2016 Bonds, including but not limited to any responsibility or obligation with respect to (i) the accuracy of the records of Cede & Co., DTC or any Participant with respect to any ownership interest in the Series 2016 Bonds, (ii) the delivery to any Participant or any other person (other than a registered owner of Series 2016 Bonds, as shown by the registration books kept by the Registrar), of any notice with respect to the Series 2016 Bonds, including any notice of redemption, or (iii) the payment to any Participant or any other person, other than a registered owner of Series 2016 Bonds, of any amount with respect to principal of, premium, if any, or interest on the Series 2016 Bonds. The Port Authority, the Registrar and the Paying Agent may treat and consider the person in whose name each Series 2016 Bond is registered in the registration books kept by the Registrar as the holder and absolute owner of such Series 2016 Bond for the purpose of payment of principal, premium and interest with respect to such Series 2016 Bond, for the purpose of registering transfers with respect to such Series 2016 Bonds, and for all other purposes. The Paying Agent shall pay all principal of, premium, if any, and interest on the Series 2016 Bonds only to or on the order of the respective registered owners, as shown in the registration books kept by the Registrar, and all such payments will be valid and effectual to fully satisfy and discharge the Port Authority's obligations with respect to payment of principal of, premium, if any, or interest on the Series 2016 Bonds to the extent of the sum or sums so paid. No person other than a registered owner of a Series 2016 Bond, as shown in the registration books kept by the Registrar, will receive a certificated Series 2016 Bond evidencing the obligation of this Resolution. Upon delivery by DTC to the Port Authority of a written notice to the effect that DTC has determined to substitute a new nominee in place of Cede & Co., the words "Cede & Co." shall refer to such new nominee of DTC; and upon receipt of such a notice, the Port Authority shall promptly deliver a copy of the same to the Registrar and Paying Agent.

- 7.03. Representation Letter. The Port Authority has heretofore executed and delivered to DTC a Blanket Issuer Letter of Representations (the "Representation Letter") which shall govern payment of principal of, premium, if any, and interest on the Series 2016 Bonds and notices with respect to the Series 2016 Bonds. Any Paying Agent or Registrar subsequently appointed by the Port Authority with respect to the Series 2016 Bonds shall agree to take all action necessary for all representations of the Port Authority in the Representation Letter with respect to the Registrar and Paying Agent, respectively, to be complied with at all times.
- 7.04. Transfers Outside Book-Entry System. In the event the Port Authority, by resolution of the Board of Commissioners, determines that it is in the best interests of the persons having beneficial interests in the Series 2016 Bonds that they be able to obtain Series 2016 Bond certificates, the Port Authority will notify DTC, whereupon DTC will notify the Participants, of the availability through DTC of Series 2016 Bond certificates. In such event the Port Authority will issue, transfer and exchange Series 2016 Bond certificates as requested by DTC and any other registered owners in accordance with the provisions of this Resolution. DTC may determine to discontinue providing its services with respect to the Series 2016 Bonds at any time by giving notice to the Port Authority and discharging its responsibilities with respect thereto under applicable law. In such event, if no successor securities depository is appointed, the Port Authority shall issue and the Registrar shall authenticate Series 2016 Bond certificates in accordance with this Resolution and the provisions hereof shall apply to the transfer, exchange and method of payment thereof.
- 7.05. Payments to DTC. Notwithstanding any other provision of this Resolution to the contrary, so long as a Series 2016 Bond is registered in the name of Cede & Co., as nominee of DTC, payments with respect to principal of, premium, if any, and interest on the Series 2016 Bond and all notices with respect to the Series 2016 Bond shall be made and given, respectively, in the manner provided in DTC's Operational Arrangements, as set forth in the Representation Letter.
- Section 8. <u>Defeasance.</u> When all Series 2016 Bonds and all interest thereon have been discharged as provided in this section, all pledges, covenants and other rights granted by this Resolution to the holders of the Series 2016 Bonds will cease, except that the pledge of the City's full faith and credit by the Port Authority for the prompt and full payment of the principal of and interest on the Series 2016 Bonds will remain in full force and effect. The Port Authority may discharge all Series 2016 Bonds which are due on any date by depositing with the Registrar on or before that date a sum sufficient for the payment, including interest earned thereon, in full of the Series 2016 Bonds. If any Series 2016 Bond should not be paid when due, it may nevertheless be discharged by depositing with the Registrar a sum sufficient for the payment thereof in full with interest accrued to the date of such deposit.
- Section 9. <u>No Designation of Qualified Tax Exempt Obligations</u>. The Series 2016-3 Bonds, together with other obligations issued by the Port Authority in 2016, exceed in amount those which may be qualified as "qualified tax-exempt obligations" within the meaning of Section 265(b)(3) of the Code, and hence are not designated for such purpose.
- Section 10. <u>Continuing Disclosure</u>. In order to satisfy the continuing disclosure requirements of Rule 15c2-12(b)(5), 17 CFR §240.15c2-12, promulgated by the Securities Exchange Commission under the Securities Exchange Act of 1934, as amended, the appropriate officials of the Port Authority are hereby authorized and directed to execute and deliver a continuing disclosure undertaking substantially in the form of the Continuing Disclosure Certificate set forth in the Official Statement (the "Continuing Disclosure Certificate"). The Continuing Disclosure Certificate is hereby approved with such changes, modifications, additions, and deletions as shall be necessary and appropriate and approved by the City Attorney and Barnes & Thornburg LLP, as bond counsel to the Port Authority.
