Dear Ms. Ortega:

The Department of Safety and Inspections (DSI) has recommended revocation of the Auto Repair Garage and Second Hand Dealer – Motor Vehicle licenses held by Phoenix Auto d/b/a 3B Auto Sales for the premises located at 1176 Dale Street North in Saint Paul. The basis for the recommendation is as follows:

**On January 8, 2018, the Department of Safety and Inspection (DSI) received a NOTICE OF LICENSE REVOCATION FOR DEBT from the Minnesota Department of Revenue requesting revocation of your Auto Repair Garage and Second Hand Dealer-Motor Vehicle licenses.**

**Minn. Stat. § 270C.72, Subd. 1 states: “The state or a political subdivision of the state may not issue, transfer, or renew, and must revoke, a license for the conduct of a profession, occupation, trade or business, if the commissioner notifies the licensing authority that the applicant owes the state delinquent taxes payable to the commissioner, penalties or interest.”**

**As a result, the Department of Safety and Inspections will revoke your Auto Repair Garage and Second Hand Dealer – Motor Vehicle licenses as of February 9, 2018, unless you resolve your tax delinquency and DSI receives a Clearance Certificate from the Minnesota Department of Revenue.**




