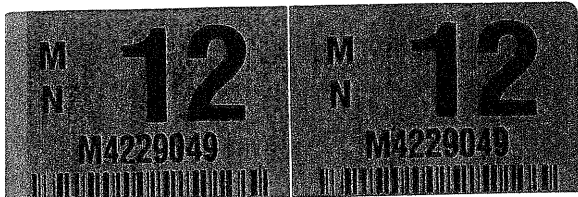
FAILURE TO COMPLY MAY RESULTS IN TAGGING AND/OR TOWING.
