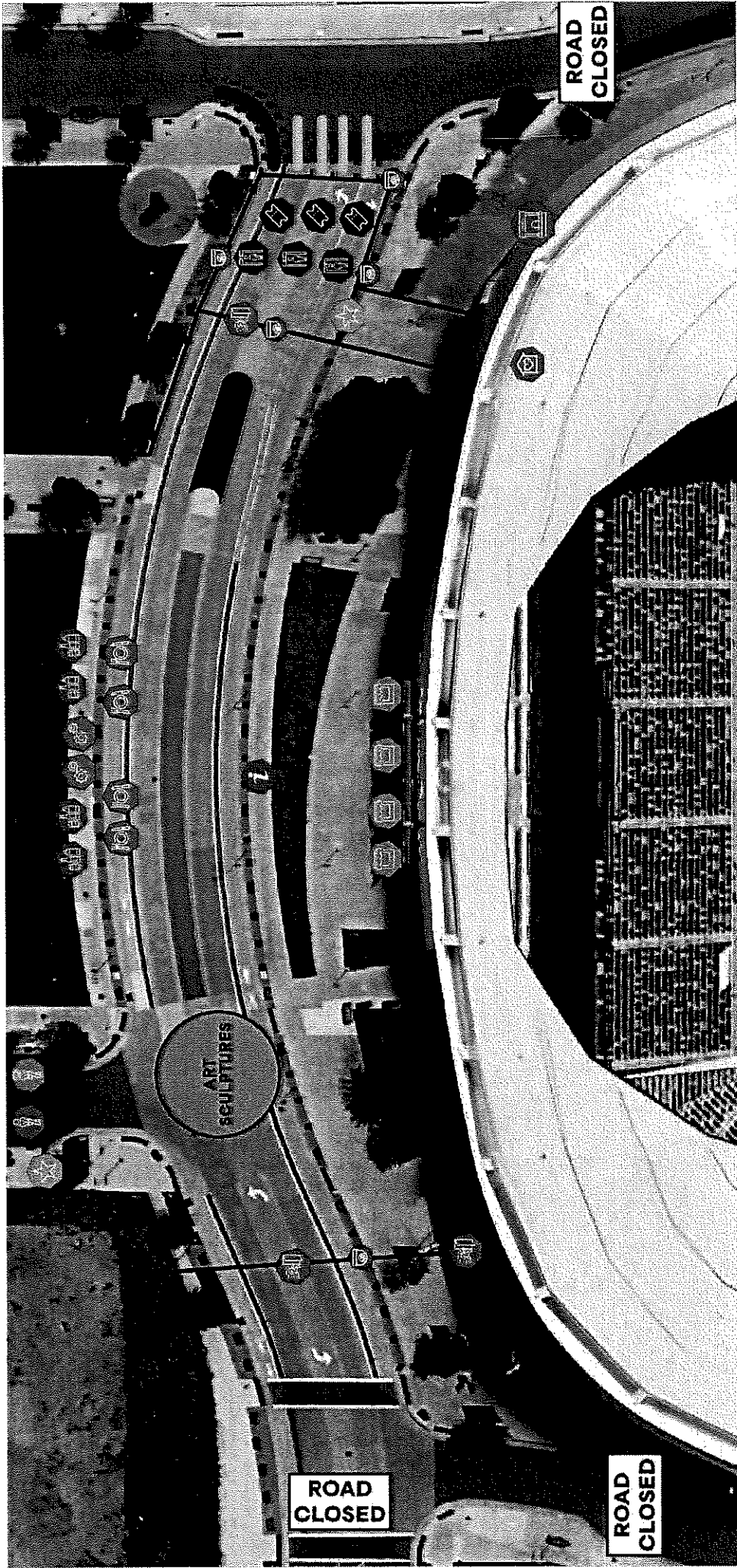
Ticketing:

Sources of Amplified Sound

Placement:

- All sound systems will be facing south to optimize acoustics and minimize sound spillage into neighboring areas.
- The area in red represented on the map will be one of our main natural resources for sound muffling.

Tents and Canopies

Sizes and Quantity:

- Majority of tents are 16x16 ft.
- 2 house mix tents, measuring 10x10 ft.

Uses: Food vendor stalls, first aid, bars.

Locations: Marked on the map in strategic locations to ensure easy access for attendees.

Stages

Main Stage Placement:

- Positioned facing south.
- Marked in purple on the map to provide the best sound experience for the audience and consider the sun's position during performances.

Portable Toilets

Quantity and Placement:

- Total of 40 regular portable toilets and 4 ADA-compliant units.
- Divided into two areas marked in green.
- Each area will have artificial hard ground for stability and accessibility.

Dumpsters

Placement:

- One central dumpster location, chosen for ease of access for waste management services while being unobtrusive to festival-goers.
- Marked on the map for clarity.

Fencing

Dimensions:

- Approximately 2000 ft of fencing will surround the festival area.
- Ensures security and delineates the event boundary.
- Marked with a brown line on the map.

Barricades

Dimensions:

- Approximately 600 ft of barricades will be strategically placed around the stage and other key areas.
- Ensures attendee safety and crowd control.
- Marked with a black line on the map.

Locations of Alcohol

Regulations:

- Alcohol consumption will be restricted to within the fenced area of the festival.
- Forbidden Festival is a 21+ event, ensuring compliance with legal age requirements for alcohol consumption.
- Marked with a purple "BAR" symbol on the map.

Other Structures

Forbidden Festival 2024

Entrance and Tunnel(Inside)

Entrance Sculptures:

- o **Location:** Positioned at the main entrance.
- o **Description:** FORBIDDEN sculpture illuminated with white lighting to set a tone of creativity and wonder as attendees step into the festival.

Red Lycra Tunnel*

- o **Location:** Directly at the entrance.
- o **Description:** A tunnel made of red Lycra that people will walk through, creating a sensation of entering a different environment.

VIP Areas

VIP Viewing Area for Fraternity Winners*:

- **Location & Size:** Positioned prominently at the front-right of the stage; area size is 80 x 16 ft*.
- **Distance from Stage:** Approximately 20 ft from the stage.
- **Capacity:** Up to 100 guests.
- **Exclusive Access:** Reserved for fraternity winners to provide a prestigious experience.
- **Marking on Map:** Blue rectangle near the front-left of the stage.

VIP Backstage Area for Sorority Winners:

- **Location:** Backstage, providing an intimate glimpse into the artist world.
- **Exclusivity:** Reserved solely for the sorority winners.
- **Privileges:** Comfortable lounge area for relaxation and socialization.
- **Capacity:** Up to 100 guests.

House Mix Station

- **Location & Dimensions:** Centrally situated in front of the stage within two 10x10 ft tents.

Core Functions:

- Controls audio-visual elements including sound, illumination, and LED panels.
- Manned by skilled technicians for optimal festival experience.
- **Impact on Festival Experience:** Ensures seamless auditory and visual experience, influencing the festival's energy and mood.

SAFETY RULES

Total of security including Security Officers, Supervisors and Event Manager:

40* This gives us 1 security per 100 people.

Entrance

We will cover the entrance with security cameras for better management

We will be using identification scanners approved by the St. Paul Police Department to check I.D. cards for authenticity.

Metal detectors will be used to check for illegal materials not entering the festival grounds.

Proof of Age

- Proof of age to enter may be established only by one of the following:
 - A valid driver's license
 - A valid state identification card or from Canada, which includes a photograph and date of birth of the person.
 - A valid military I.D. issued by the U.S. Dept. of Defense
 - A valid passport
 - A valid tribal I.D

It is prohibited to:

- ridiculing gender stereotypes, sexual orientation, ethnicities and beliefs;
- use of blackface;
- political costumes;
- any kind of cultural appropriation.

FBDN Ventures and O Gruppo(GRPP Ventures) repudiate any abusive, oppressive or prejudiced behavior!

People who disobey the rules will be removed from the festival without refund.

Inside Festival Grounds

- Uniformed Minneapolis Officers for additional security
- 65 well trained bartenders from Best Beverage Catering, a dynamic, nationwide event company, providing next generation food & beverage experiences at festivals, sporting events, clubs & private events.
- Well-marked emergency exits
- Entry will be until 7pm, after that people will be free to leave, but no one will be allowed to return to the Festival grounds.
- Just biodegradable plastic cups are going to be used at this event.
 - Attendees will be encouraged to bring their own cups(they can bring their own reusable cup from home or buy a personalized Forbidden Eco-cup online)
 - Aluminum and/or metal and/or glass mugs are not allowed for safety reasons.

Emergency Protocols for Forbidden Festival 2024

Forbidden Festival 2024

1. Emergency Coordination Center (ECC)

- Location: On-site office near the ticket office.
- Role: Central hub for managing emergencies.
- Staff: Event Manager, Security Supervisor, Medical Lead.

2. Communication Plan

- Primary: Two-way radios for all key personnel.
- Backup: Mobile phones.
- Code System: Use pre-agreed codes for different types of emergencies (e.g., Code Red for fire, Code Blue for medical emergencies).

Specific Emergency Protocols

1. Medical Emergency

- Detection: Any attendee or staff can report a medical emergency to the nearest security personnel or staff member.
- Response:
 - Security personnel notify ECC and call for a medical team.
 - Medical team arrives on scene within 5 minutes.
 - Assess the situation and provide necessary first aid or emergency care.
 - If required, contact ambulance services and arrange transportation to the nearest hospital.
- Documentation: Complete an incident report detailing the nature of the emergency, response actions, and outcome.

2. Fire Emergency

- Detection: Any sighting of smoke or fire should be immediately reported to the ECC.
- Response:
 - Announce a Code Red over the communication system.
 - Security personnel activate the fire alarm and initiate evacuation procedures.
- ECC contacts the Fire Department.
- Use available fire extinguishers to control small fires if safe to do so.
- Evacuation:
 - Direct attendees to the nearest emergency exits.
 - Ensure all areas are cleared, especially high-traffic areas and stages.
 - Assemble at the designated assembly points.
- Documentation: Complete an incident report with details of the fire, response, and any injuries or damages.

3. Severe Weather (e.g., Thunderstorms, Tornadoes)

- Detection: Monitor weather reports continuously. Any severe weather alerts should be reported to the ECC immediately.
- Response:
 - Announce the situation over the communication system.
 - Direct attendees to indoor or sheltered areas within Allianz Field.
 - Suspend performances and activities until it is safe to resume.
 - If necessary, initiate evacuation procedures.
- Documentation: Log weather updates and any actions taken in response.

4. Security Threat (e.g., Active Shooter, Bomb Threat)

- Detection: Any suspicious activity or threat should be reported to security personnel immediately.
- Response:
 - Announce a Code Black over the communication system for security threats.
 - ECC contacts the Police Department and follows their instructions.
 - Security personnel to initiate lockdown or evacuation procedures as advised.
 - Avoid using radios or mobile phones if a bomb threat is suspected to avoid triggering devices.
- Evacuation/Lockdown:
 - Direct attendees to designated safe areas or exits.
 - Ensure clear communication to avoid panic.
- Documentation: Complete an incident report with details of the threat, response actions, and any outcomes.

5. Missing Person

- Detection: Report of a missing person to the nearest security personnel.
- Response:
 - Announce a Code Yellow for missing persons.
 - Security personnel spread the description and last known location of the missing person to all staff.
 - Designate a reunification area where missing persons can be brought and reunited with their parties.
- Search:
 - Conduct a thorough search of the festival grounds.
 - If the person is not found within 30 minutes, contact local law enforcement for assistance.
- Documentation: Complete an incident report detailing the missing person's description, search actions, and outcome.

Post-Incident Procedures

1. Debriefing

- Conduct a debriefing session with key personnel to review the incident.
- Identify strengths and areas for improvement in the response.

2. Support Services

- Provide counseling and support services for those affected by the incident.
 - Ensure follow-up care and assistance as needed.
- 3. Reporting**
- Compile a comprehensive report on the incident, including all documentation and incident reports.
 - Share the report with relevant authorities and stakeholders.

Emergency Equipment and Supplies

- 1. Emergency Exits**
 - Clearly marked and illuminated exits throughout the venue.
- 2. Fire Extinguishers**
 - Located at strategic points throughout the festival grounds.
- 3. First Aid Kits**
 - Available at multiple locations, including the ECC and medical tents.
- 4. Communication Devices**
 - Ensure all key personnel have functional two-way radios and mobile phones.

Conclusion

Regularly review and drill these protocols with all staff and volunteers to ensure preparedness. Communication and coordination with local emergency services are crucial for a safe and successful event.

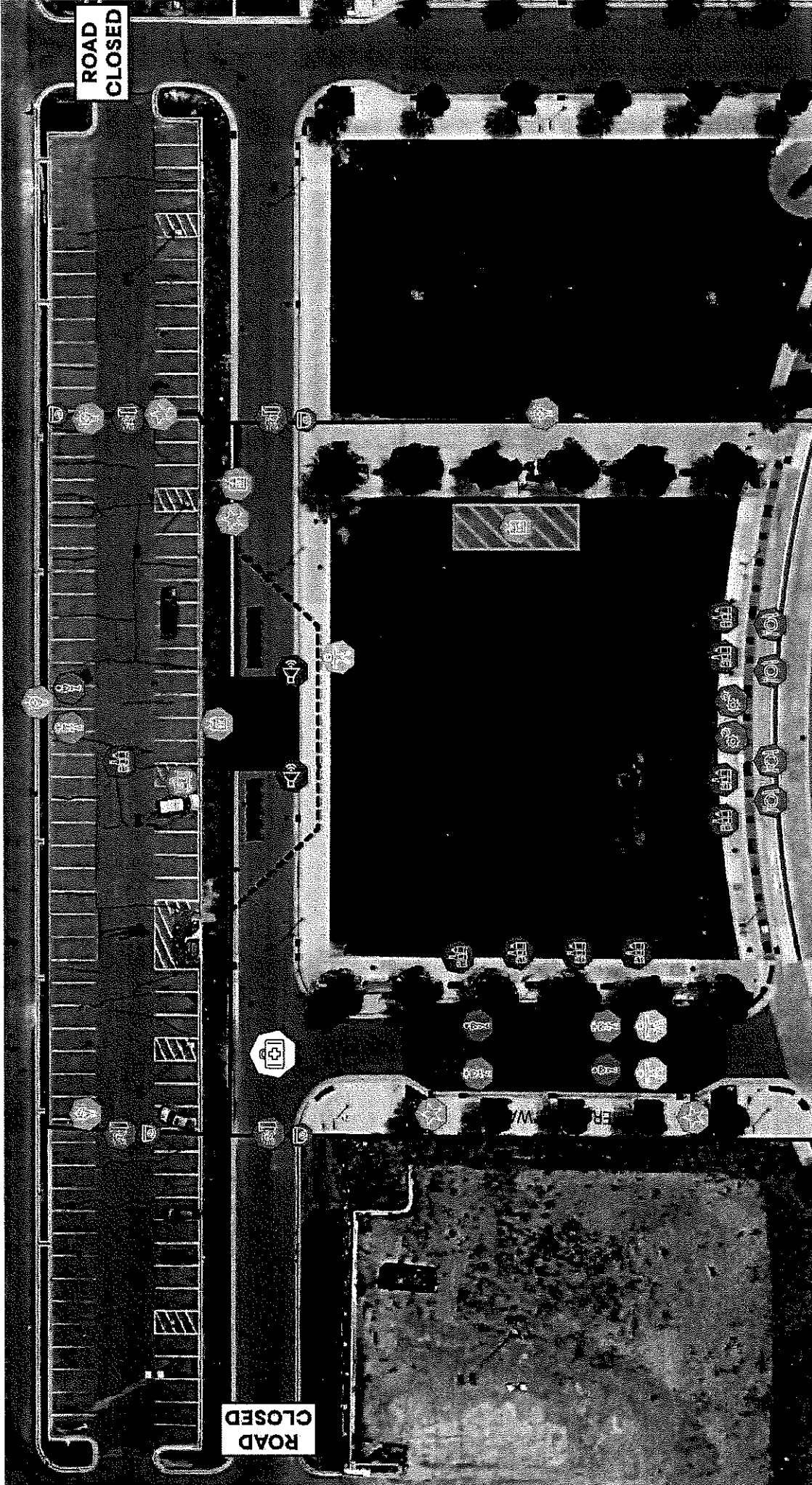
