APPEAL of the Fire Inspection deficiency notice on the property located at 1569 Race St, MN 55102, dated 12/28/2010.

By this petition I would like to file the appeal of section 5 of the deficiency report having to do with the improper window sizes to provide escape from sleeping rooms. The property 1569 Race Street was built in the 1880s and is now nearly 130 years old. Obviously, building codes at the time were different that current regulations. The existing window cells are only 1-1.5" smaller than current code requirements and provide ample escape for an emergency exit. I would like to petition to have the property at 1569 St. be grandfathered in under the current codes due to it's age and construction. Modification of the existing windows in the house would place an unreasonable financial strain on us and may exceed the actual cost of the house in the market. #### Dear Property Representative:

Your building was inspected on December 28, 2010 for the renewal of your Fire Certificate of Occupancy. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected prior to the re-inspection date. A reinspection will be made on January 28, 2011 at 10:00 AM.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

#### DEFICIENCY LIST '

- 1. Basement Waste pipe SPC 4715.1430, & 1440 Provide approved support for all plumbing piping. This work may require a permit(s). Call LIEP at (651) 266-9090.
- 2. Basement SPLC 34.11 (4), 34.34 (1), MPC 4515, MPC 326 Connect or cap the sewer piping in accordance with the plumbing code. This work may require a permit(s). Call LIEP at (651) 266-9090.
- 3. Basement steps SPLC 34.10 (3) 34.33(2) Provide an approved guardrail. Intermediate ballustrade must not be more than 4 inches apart. Intermediate rails must be provided if the height of the platform is more than 30 inches.

- 4. Basement steps SPLC 34.10 (3), 34.33(2) Provide an approved handrail. The top of the handrail must be between 34 and 38 inches above the treads and run the entire length of the stair.
- 5. Bedrooms MSFC1026.1 Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651)-266-9090. Refer to the Escape Windows for Residential Occupanices handout for more information.-

20.5 h x 31 w Glazed 7.8 sq ft
First floor west
22 h x 28 w Glazed 9.2 sq ft
Second floor east
20.5 h x 26 w Glazed 7.2 sq ft

- 6. Front steps SPLC 34.09 (2) 34.32 (2) Provide an approved handrail. The top of the handrail must be between 34 and 38 inches above the treads and run the entire length of the stair.
- 7. Second floor west bedroom closet door SPLC 34.12 (2), 34.35 (1) Repair and maintain all required and supplied equipment in an operative and safe condition.
- 8. Second floor west bedroom SPLC 34.09 (3), 34.32 (3) Repair and maintain the window glass.
- 9. Sleeping rooms MN State Statute 299F.50 Immediately provide and maintain an approved Carbon Monoxide Alarm in a location within ten (10) feet of each sleeping area. Installation shall be in accordance with manufacturers instructions.
- 10. Throughout MSFC 605.4 Discontinue use of all multi-plug adapters.-Including the living room and basement.
- 11. Throughout MSFC 605.5 Discontinue use of extension cords used in lieu of permanent wiring.-Including basement.
- 12. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
- 13. SPLC 39.02(c) Complete and sign the provided smoke detector affidavit and return it to this office.
