Good morning,

This email is to confirm that at the November 21, 2023 Legislative Hearing for your appealed tax assessment at 522 MISSISSIPPI RIVER BOULEVARD NORTH. (File No. VB2402, Assessment No. 248801) the Legislative Hearing Officer recommended that the City Council **delete the assessment**.

This is currently scheduled to go before the City Council at Council Public Hearing on **Wednesday, January 24, 2024 at 3:30 pm. in room 300 City Hall**. However, no further action is needed and the Council will proceed with Ms. Moermond's recommendation above. Note that this will remain as a pending assessment until after the Council vote in January, when will be removed.

Additionally, **your property requires a Fire Certificate of Occupancy to be a rental**. You can find information, including a provisional application online here: <https://www.stpaul.gov/departments/safety-inspections/rent-buy-sell-property/maintaining-your-property/fire-safety-and-habitability>

As noted in the hearing, this property is currently Homesteaded with Ramsey County. If you are no longer an owner occupant, as you indicated in the hearing, you should speak with them about that.
