Description of Variance

Location: Mears Park

Noise Source: B Horst Productions, Brian Horst, Director, has applied for a sound level variance, at a requested sound level of 90-100 dBA at no specified distance, in order to provide music outdoors at Mears Park on twelve (12) Thursdays, beginning June 8 through August 24, 2017. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for amplified music for the hours from 6:30 p.m. until 9:30 p.m., with a pre-event sound check from 5:00 to 6:00 p.m., on twelve (12) Thursdays starting June 8 through August 24, 2017. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 90 dBA, as measured at 50 feet from the noise source from 6:30 p.m. until 9:30 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:30 p.m. on each event date.

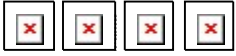
