**LEGISLATIVE HEARING ITEMS FOR DISCUSSION**

**56**    [RLH TA 19-527](#)                      Ratifying the Appealed Special Tax Assessment for property at 1137 JESSIE STREET. (File No. J1923A, Assessment No. 198556)

*Legislative Hearing Officer Marcia Moermond gave a staff report on the assessment for a clean-up of a Bagster in the driveway apron on the Geranium side of property. She said Parks crews initially went to the Jessie side of the property and didn't see the Bagster, closed it out as abated. Neighbors continued to complain, and a crew went back out and removed it. The total assessment was \$534, including the service charge. Ms. Moermond said the property owner stated the Bagster was placed there by the neighbor, and he was not checking mail regularly to know he should be talking care of it. She recommended that the assessment be approved. Although the item was dumped, there were ample opportunities for it to be addressed and it was there for a matter of months.*

*In opposition:*

*Steve Getz (641 Huntington Court, Maplewood) said he lived at the house until 3-4 years ago and was taking his time getting it ready to sell. He said he didn't check on the property as much as he should, and when he did, he went in the front door. He said the neighbor on Geranium often had squatters, and garbage got dumped. He said he called and was told it had been taken care of already, and when he prior to that, City staff couldn't find the orders. He said he went to the property to check when he got the second notice, and there was nothing there. It was most likely the day after they picked it up. He said he was at fault, and all he would have had to do was call Waste Management to pick it up. He said the inspector was hard to get a hold of. He said he saw the video of the clean-up, and the charge seemed excessive for the work done. He said \$534 was a very big deal for him, and he would try to stay on top of it and not take it lightly. He said he would like the Council to at least chop the fee in half.*

*Council President Brendmoen moved to close the public hearing. Yeas - 7 Nays - 0*

*Council President Brendmoen said there was a cost associated with these clean-ups, and she didn't hear anything that made her believe they should pass the cost along to other rate-payers in the city. She moved Ms. Moermond's recommendation.*

*Legislative Hearing Officer Marcia Moermond gave a staff report on the appeal of the revocation and order to vacate. She said this was a long-term problem property; she described the violations. She recommended that the property be ordered vacated or the work completed by September 10, with a three-week grace period to October 1 to allow the Certificate of Occupancy to be reinstated or the building referred to the vacant buildings program. She said the owners indicated they had discussed eviction with the tenants and given them letters. She said she had heard this property in the past for clean-ups, and there were similar conversations months ago. She said there hadn't been a proper legal process executed on the part of the owner, and the work continued to not be done, and therefore she was ordering that the property be vacated. She said the owner was present to ask for an extension. In response to a question from Councilmember Jalali Nelson, she reviewed the deadlines and the corrections that needed to be made.*

*In opposition:*

*Property owner Cornelius E. Brown asked for a three-week extension.*

*Councilmember Jalali Nelson reviewed the items to be completed, and said they looked like a number of small but doable things. Mr. Brown said the drug dealers had agreed to move out by Friday; he said the plumbers and electricians hadn't been able to get in.*

*Councilmember asked Mr. Brown if he had the resources and time to do everything in six days. Mr. Brown said if he could have a three-week extension he'd make sure everything was done.*

*Council President Brendmoen asked Mr. Brown if he was the landlord. Mr. Brown said he was the landlord and co-owner. He said everyone would be out by Friday, and workers could start.*

*Councilmember Jalali Nelson asked who lived there now. Mr. Brown said no one lived there. He said they had moved out and the place would be empty as of Friday.*

*Councilmember Jalali Nelson moved to close the public hearing. Yeas - 7 Nays - 0*

*Council President Brendmoen reviewed the situation.*

*Ms. Moermond said the concern was that in spite of multiple attempts and letters asking the tenants to leave, they had not actually left. They might not be physically there but their possessions were and there was no legal means in place to force them to vacate, in terms of the landlord following legal procedures; the City's order to vacate was the only tool. She said Mr. Brown had a de facto extension built into the recommendation.*

*Councilmember Noecker said it seemed like the recommendation was already granting what was being requested.*

*Councilmember Jalali Nelson asked whether the recommended deadlines were formalized somewhere. Ms. Moermond said it was in the resolution before the Council.*

*Councilmember Jalali Nelson said her concern was displacing the tenants, but it sounded like they were making their way out and the needed repairs were going to happen. She moved to adopt Ms. Moermond's recommendation.*

*In opposition:*

*Jacob Bernstein (1601 Sherburne Avenue), Imperial Vapor, said there were massive differences between traditional tobacco and vaping products; vapor products were not made by big tobacco. He said there needed to be lenience; asking them to completely adapt and change within 30 days was unreasonable. He said tobacco tax dollars paid for tobacco control and education programs. He said the ordinance would disproportionately impact vulnerable communities, especially the minor possession pieces of the ordinance, and it would do nothing to address online sale. He said no teenagers were getting their products from Imperial Vapor, and the ordinance would eliminate responsible retailers as a source of products for 18+ year olds.*

*Dan Bernstein (6200 Westedge Boulevard, Mound), Imperial Vapor, said they opposed the ordinance overall, they supported any amendment that would remove penalties on minors.*

*Robert Dwyer (6101 Cedar Lake Road, St. Louis Park), Imperial Vapor, said based on his experience, blanket T21 laws didn't work.*

*Sid Weik (1765 Carroll Avenue) said he opposed blanket T21 laws, support removing penalties on minors*

*Troy DeCorsey, Vape Pros, said he agreed with the previous testimony. He said most people didn't understand that vaping wasn't bad, vaping was not the problem. He asked that the Council do their research. He said big tobacco owned Juul, and Juul was the problem.*

*Council President Brendmoen asked what percent of her customers were between 18 and 21. Mr. DeCorsey estimated 30 to 35%.*

*Council President Brendmoen asked the same question of Imperial. Mr. Jacob*

*Bernstein said 28 to 30%.*

*Mike Weis (1239 7th Avenue S., S. St. Paul), Vape Pros, said St. Paul compliance checks had shown that sales at the store level were not the problem. He asked that the Council look at the scientific data, and he suggested rewriting a grandfather clause for people already of age. He said people already using products as a harm-reduction, especially in sober programs, represented a large proportion of their customers, and would be negatively impacted. He said he supported removing penalties for minor purchase and possession, as long as the City also got rid of online sales.*

*Council President Brendmoen clarified that the first item was to raise the age to enter a liquor store.*

*Councilmember Jalali Nelson confirmed that would mean the vote would not be taken for 30 days. Councilmember Thao said they would continue the public hearing, and vote. Councilmember Jalali Nelson asked when the effective date would be in that case. City Clerk Shari Moore said it would go into effect 30 days after publication.*

*Councilmember Noecker said another option would be to continue with passage of the ordinance without that amendment, and introduce the amendment separately after a 30-day notice.*

*Councilmember Brendmoen said there was a motion for Version 2, and she was looking for support or opposition to that motion.*

*Councilmember Tolbert spoke in support.*

*Councilmember Noecker said she supported the content but didn't like that it meant they had to wait another month.*
