Subject: Initial Research on "Exhibition Driving" in Municipal Code

Several Minnesota municipalities have adopted ordinances banning "exhibition driving"—including behaviors such as burnouts, squealing tires, and unnecessary engine noise. These local ordinances serve an important role in discouraging dangerous or disruptive driving, particularly since Minnesota state law does not explicitly address this type of conduct.

The table below summarizes preliminary research conducted by Ward 2 on this issue. Please note that the list is not exhaustive; other municipalities may have similar provisions that are not included here.

Initial research also indicates that the City of Saint Paul does not currently include any language related to "exhibition driving" in its municipal code.
