Joanna:

I wanted to reach out regarding the demo fee on 857 Lafond that is currently scheduled for CPH on 7/16/25. My buyer, Matt Heimann, is interested in the property, but he would want the assessment to be scheduled over an extended period of time. I know this is possible. That said, Mr. Heimann would not be the legal owner by CPH on 7/16/25. Since it is a public hearing, could we still make the request to have the fee extended over a period of time even though Mr. Heimann would not be the legal owner? The problem lies in that he only wants to purchase the property if this fee could be paid over time, as he is unable to pay \$34K in one tax year for this fee.

Property is corporate owned making it difficult for us to ask the seller to attend the hearing and extend the time frame of the tax payable.

I have been in contact with the city regarding a property that was down the street from my blair house. Anyway, Long story short, I tried to buy it over the years since it was vacant and this past year, it was demolished by the city. So I'd like to buy the land. The property is listed for 27k or so. But there will be over 30k in assessment by the city for 2026 year for the demolition costs.

My goal would be to buy the property for say \$1.00 but take on the demo fee assessment. It's the current owner's benefit. The reason I want to try this is that I can get the Demo fee to be assessed over 10 years so it's not one big chunk payment. This is a property that I want to build for sale units in the next year or so.

Property is 857 Lafond Ave. I have been told the property is owned by a bank now. I have some correspondence with the listing agent but they are out of state and were pretty hard to get a hold of.

If there is a way to explain all of this to the owner, that would be great.
