Description of Variance:

Location: 400 Snelling Ave. N. – Amplified sound within the Street and the Beer Garden Area outside of Allianz Field

Noise Source: Zacharia Litzelswope, MNUFC Director, Events and Guest Experience, has requested two sound level variances for 95 dBA at no specified distance to present amplified sound with use of a sound system for the MNUFC v Seattle game at 400 Snelling Ave. N- Amplified sound within the Street and the Beer Garden Area – outside of Allianz Field. The variances are requested for the hours of 12:00 p.m. to 3:30 p.m. with a pre-event sound check at 11:00 a.m. for the MNUFC v Seattle game and from 4:00 p.m. to 7:30 p.m. with a pre-event sound check at 3:00 p.m. for the MNUFC v Colorado game. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variances shall be for the hours of 12:00 p.m. to 3:30 p.m. with a pre-event sound check at 11:00 a.m. on Sunday, August 27, 2023 for the MNUFC v Seattle game and from 4:00 p.m. to 7:30 p.m. with a pre-event sound check at 3:00 p.m. on Wednesday, August 30, 2023 for the MNUFC v Colorado game. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources on August 27, 2023 and on August 30, 2023. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 3:30 p.m. on August 27, 2023, for the MNUFC v Seattle game and 7:30 p.m. for the MNUFC v Colorado game.

Submit comments for Public Hearing electronically. The public may comment on public hearing items in person, in writing or via voicemail. Any comments and materials submitted by 12:00 pm of the day before the meeting, Tuesday, August 15, 2023, will be attached to the public record and available for review by the City Council. Comments may be

submitted as follows: Written public comment on public hearing items can be submitted to Contact-Council@ci.stpaul.mn.us, CouncilHearing@ci.stpaul.mn.us, or by voicemail at 651-266-6805. Live testimony will be taken in person in the Council Chambers, and by telephone by registering to speak by noon on the day before the meeting.
