The same person (Vlada Gazalabova) filed six appeals (\$150) on behalf of her property maintenance company – BLM Management. All for TG & W, except 929 6th Street - which was TG & W plus refuse. That one went to WO by our “problem property person” and was done by Parks today, both grass and refuse. 1083 Beech is currently in compliance, but the grass is about 6” and will be out of compliance soon. The others appear to now be in compliance. I will try to sort this out in the morning, but informed Vlada today if she was only seeking extensions, she could have called the various inspectors, rather than submit appeals. I am unsure if she will attend the hearing.
