Requested Board Action

Public hearing and authorization providing consent to the issuance of bank qualified debt by the

City of Falcon Heights on behalf of Heritage Apartments, Inc. for their project located at 1440

Midway Parkway.

Background

REGARDING:

Heritage Apartments, Inc. is a non-profit corporation (the "Borrower") that owns and operates a

60-unit senior rental facility located at 1440 Midway Parkway. In 2009, the HRA issued

\$3,200,000 of conduit housing revenue bonds to refinance bonds issued in 1993 by the HRA,

which proceeds were used to finance the construction of the Heritage Apartments Project (the

"2009 Bonds"). The outstanding principal is approximately \$1,650,000.

The Borrower is proposing to refund the 2009 Bonds through tax-exempt obligations issued by the

City of Falcon Heights (the "Issuer") in the approximate amount of \$1,700,000 (the "Project").

Bremer Bank (the "Bank") has agreed to finance the Project through the purchase of a tax-exempt

note (the "Note"), but their commitment to finance the Project is conditioned upon the Note being

designated by the issuer as a "qualified tax-exempt obligation" ("Bank Qualified") under Section

265(b) of the Internal Revenue Code. In order to be designated as Bank Qualified, an issuing city

can issue no more than \$10,000,000 in qualifying obligations during the calendar year.

The HRA is not able to issue Bank Qualified obligations in any calendar year because we expect

to issue more than \$10,000,000 in obligations for use by other nonprofit organizations or for our

own corporate use. With the Bank Qualified designation, the Bank is able to offer a lower interest rate on the obligations to the Borrower due to the federal taxation of certain carrying costs of the obligations. The Port Authority would generally be able to issue Bank Qualified obligations, however in this case they indicated they do not have capacity to finance the Project prior to the end of the year.

Since the Project is located within Saint Paul, Section 147(f) of the Internal Revenue Code requires that the HRA approve the issuance of the Note following a public hearing (i.e. Host Approval), and that the HRA consent to the refunding of the 2009 Bonds.

Financing Structure

The Note will be payable solely from revenues of the Borrower, will not be a general or moral obligation of the HRA, the City, the Issuer, or any other political subdivision of the State of Minnesota, but will be payable solely from revenues of the Borrower. Minnesota law requires the execution of a Joint Powers Agreement between the Issuer and the host city (the HRA).

PED Credit Committee Review

The PED Credit Committee reviewed the request to provide consent on December 4, 2018, and found it to be consistent with PED's policies when requesting Host Approval for Bank Qualified Bonds.
