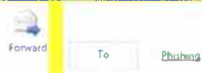

The way that the change to your license will happen from the City side is that we are going to remove the one condition on your license. Once that condition is removed, you will be able to operate without the required food component. In order to do that, a 15 day Public Notification will need to go out and due to a change in license procedures, you will need to send the attached document to your district council letting them know that you are requesting the condition to be removed.
