Thank you for the prompt follow up. I just found a stack of mail from your office that came to our Florida winter home and wasn't forwarded to our Minnesota address like it should have been. As I mentioned to the person who referred me to you, the third floor attic "unit" is not now, and has not in the past been occupied. My former property manager, who recently passed away, had planned to buy the property from me and had started the process of turning the duplex into three condo units. Unfortunately, circumstances prevented him from moving forward in a timely manner, and it now appears that the third floor attic will never be converted to a separate habitable unit. I see that we have been being billed for garbage service for unit #3 for I don't know how long. Lou did not leave me with very good records. Furthermore, the property is being billed for four large garbage cans when there are only two on the property. Is it possible to receive a credit for the erroneous billings?

To be clear, the first floor unit is the only one occupied at the moment, so only one garbage can is needed at the property for now.
