DESCRIPTION

The Saint Paul Fire Department would like to replace necessary equipment that is obsolete and in ill-repair to increase our operational capability and efficiency in training programs. We are requesting funding to replace our air compressor and add an additional SCBA fill station with more capable, more efficient and more reliable equipment. Our current compressor is 24 years old, severely undersized, needs multiple repairs in a year, and is no longer capable of achieving 4500 PSI. The compressor was purchased prior to SPFD converting to 4500 PSI SCBA systems. Our accompanying fill station is 19 years old and has the capacity to only fill 3 bottles at a time. Replacing this equipment will improve operational safety upon install. Article 1**Assurances, Administrative Requirements, Cost Principles, Representations and Certifications**

I. As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project but are not an integral part of the structure or permanently affixed to the infrastructure project. Waivers When necessary, recipients may apply for, and the agency may grant, a waiver from these requirements. (a) When the federal agency has made a determination that one of the following exceptions applies, the awarding official may waive the
