Description of Variance:

Locations: 242 7th Street West

Noise Source: Burger Moe's has requested a sound level variance, at a requested sound level limit of 100-95 dBA at 50 feet from the source, to present amplified music in an enclosed tent with use of a sound system for a St. Patrick's Day Event on Friday, March 17, 2017 at 242 7th Street West. The variance is requested for the hours of 12:00 p.m. on March 17, 2017 until 1:00 a.m. on March 18, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 12:00 p.m. until 11:59 p.m. on Friday, March 17, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 95 dBA as measured at 50 feet from the sound sources outside of the fully enclosed tent. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:59 p.m. on March 17, 2017.

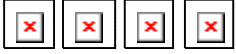
