NOTICE OF PUBLIC HEARING

Become Co/Red Bull Frozen City Event 2016 Sound Level Variance 2

TO: Frogtown Neighborhood Association

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance (SLV #2):

Locations: Shot 8, Roberts Street North and the State Capitol Overlook

Noise Source: Become Co/Red Bull Media House Frozen City Event 2016, represented by Luke Seile, Managing Partner/ Producer, has requested a sound level variance in order to use a specialized snowmobile for Sound Level Variance 2 (SLV#2) at the following locations: Shot 8, Roberts Street North and the State Capitol Overlook. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The SLV #2 Variance shall be for the hours of 8:00 a.m. to 6:00 p.m., with a pre-event sound check from 7:30 a.m. to 8:30 a.m. on Sunday, January 10, 2016, Sunday, January 17, 2016 and/or Sunday, January 24, 2016 for the following locations: Shot 8, Roberts Street North and the State Capitol Overlook. 2. All noise coming from the specialized snowmobile used in conjunction with the event shall not exceed 91 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All specialized snowmobile sound shall be turned off no later than 6:00 p.m. on Sunday, January 10, 2016, Sunday, January 17, 2016 and/or Sunday, January 24, 2016.
