Hi All,

Please clarify with me why there are two VB fees? One VB fee, VB1410, went to hearing on 7/8/14. MM gave owner until July 18 for compliance and if he is done, the assessment will be reduced from \$1595 to \$200. On July 15, Samson Mengesh called and stated they are done with everything with the exception of the plumbing permit and building permit due to scheduling conflict. I consulted with Marcia and she said for him to call Steve Ubl and he can have the inspectors expedite the appointment. This did not happen. Today he called me again stating that final inspection was

done today. This VB fee is in front of Council on August 20. He now receives another VB fee, VB1411, scheduled for August 5 LH.
