

APPLICATION FOR ADMINISTRATIVE SEARCH WARRANT AND SUPPORTING AFFIDAVIT

Steve Magner, Supervisor of Code Enforcement for the City of Saint Paul, (hereinafter "Affiant") being first duly sworn, hereby makes application to this Court for an administrative search warrant pursuant to Saint Paul Legislative Code §§ 34.19 and 45.07 to search the Property, hereinafter described, located in the City of Saint Paul, County of Ramsey, State of Minnesota, for evidence of the conditions hereinafter described.

Affiant knows the contents of this application and supporting affidavit, and the statements herein are true of his own knowledge, save as to such as are herein stated on information and belief, and as to those, he believes them to be true.

Affiant has good reason to believe, and does believe, that the following described property and things, to wit:

Accumulated refuse and debris, including, but not limited to accumulated household garbage (some of which may be subject to decomposition).

Accumulated animal and vegetable waste resulting from the handling, preparation, cooking or the consumption of food.

Accumulated waste paper and similar debris.

Human and/or animal excrement and/or other waste.

Documents that tend to show residency and/or occupation of the residential dwelling.

will be at the Property, described as:

Single-Family Residence owned and/or occupied by Richard J. Ayd located at 1698 Lafond Avenue.

Located in the City of St. Paul, County of Ramsey, and State of Minnesota.

Affiant applies for issuance of an administrative search warrant upon the following grounds.

- 1. The owner and occupant of the property described has a duty to permit entry for the purpose of inspection and examination pursuant to Saint Paul Legislative Code §§ 34.19, and §45.07.
 - a. Saint Paul Legislative Code §34.19 states:

Enforcement officers shall be authorized to make or cause to be made inspections to determine the condition of buildings, dwelling units, guest rooms, habitable rooms, premises, residential structures, rooming houses, rooming units, commercial structures and other structures or premises at any reasonable time in order to safeguard the health, safety and welfare of the public and to perform their duties under this chapter. Access during reasonable times shall not be denied by any owner, occupant or other person in charge of the premises. The enforcement officer may obtain a search warrant where probable cause exists to believe that the premises are in violation of this chapter.

b. Saint Paul Legislative Code § 45.07 states:

The enforcement officer shall be authorized to enter any property or structure in the city for the purpose of enforcing and assuring compliance with the provisions of this chapter. An owner or responsible party shall, upon the request of the enforcement officer, provide access to all interior portions of a building in order to permit the officer to make a complete inspection.

- 2. Affiant has a duty and is authorized to placard any structure or portion thereof ordered vacated pursuant to Saint Paul Legislative Code § 34.23 (3).
 - a. Saint Paul Legislative Code §34.23 (3) states:

Placard as unfit for occupancy. Any dwelling unit, structure or portion thereof ordered vacated or condemned as unfit for occupancy shall be posted with a placard by the enforcement officer.

- 3. Affiant believes that the property currently poses a material endangerment and exposes the occupants and/or the public to danger or peril, pursuant to Saint Paul Legislative Code §34.23(7) b.
 - a. Saint Paul Legislative Code §34.23(7)b states:

- (7) Material endangerment violations. The following violations may constitute material endangerment if in combination or alone the conditions are substantial and expose the occupants or the public to danger or peril:
 - (b) Fire hazard. Whenever the dwelling unit, structure, or any portion thereof, because of obsolescence, dilapidated condition, deterioration, damage, inadequate exits or access to exits, lack of sufficient fire-resistive construction, faulty electric wiring, gas connections or heating apparatus, or other cause, is determined by the enforcement officer to be a fire hazard.
- 4. Affiant further believes that the Property described above may require abatement pursuant to Saint Paul Legislative Code Chapter 45 and Minnesota Statutes Section §145A.04, Subd. 8. (Copy of Ordinance and Statute attached).

The facts tending to establish the foregoing grounds for issuance of an administrative search warrant are as follows:

Affiant is a Supervisor of Code Enforcement for the Department of Safety and Inspections (DSI) for the City of Saint Paul. Affiant's duties include oversight of the vacant building program and inspecting buildings for compliance with all applicable codes including the Minnesota Building Code, International Building Code and the Saint Paul Legislative Code. Affiant has investigated numerous cases involving hoarding behaviors and has partnered with Ramsey County Mental Health Services on numerous occasions to address code, public health and safety issues related to other similar properties within the City of St. Paul.

On March 10, 2011, while working in his capacity as the Supervisor of Code Enforcement, Affiant was assigned a case at the Property involving the existence of immediate hazards to public health and safety. Affiant, in his capacity as Supervisor of Code Enforcement, oversaw the abatement of hazards to public health and safety in the interior and exterior of the Property in 2011.

Since the initial interior abatement in 2011, Affiant and staff have monitored the Property as a vacant building. Affiant and staff have looked for evidence of occupation and reestablishment of public health hazards, safety hazards and nuisance conditions. During routine checks in both the day and evening hours employees of the Department of Safety and Inspections have not been able to find the owner present at the residence. Attempts to contact the owner have gone unanswered (see attached STAMP report). While occupation and reestablishment of the public health, safety hazards and nuisance conditions has been suspected, evidence had not been obtained to support that suspicion.

Affiant has abated a number of plainly visible outdoor nuisances which supported his suspicion that the owner was reestablishing the public health, safety hazards and nuisance conditions at the property (STAMP report attached).

On December 7, 2015, Affiant was provided with a detailed report from the St. Paul Police Department and believes the following constitutes Probable Cause to search the above-mentioned Property:

On November 24, 2015, officers were sent to assist Parking Enforcement Officer Toupal with a welfare check. Parking Enforcement Officer Toupal was at the property on a parking related compliant and attempted to make contact with the owner. Parking Enforcement Officer Toupal found the rear door of the Property open. Assisting officers responded and documented that as they were approximately 5 to 8 feet away from the door, they could smell urine and feces coming from inside 1698 Lafond. When they got to the door, it appeared the door would not close due to garbage in the entry/kitchen area. They noted that the smell coming from inside the Property was unbearable. They documented that they almost vomited from the smell of rotting feces, urine and other rotting smells. They further noted that they were not able to enter the house without climbing over a pile of garbage. Concerned about the welfare of the Property owner, officers spoke with a neighbor who relayed that he had seen the owner approximately one hour before police arrived at the property. With that knowledge, officers left the Property and reported their findings to Sargent Charles Graupman in Western District Force Unit. Sargent Charles Graupman directed them to write a report (CN 15252263, attached), which was forwarded to the Affiant and St. Paul City Attorney's Office so that an administrative warrant to enter the Property could be prepared.

Your affiant believes it necessary to obtain a search warrant to gain entrance to 1698 Lafond Avenue, in order to inspect the Property for conditions which constitute material endangerment and expose the occupants and/or the public to danger or peril, pursuant to Saint Paul Legislative Code §34.23(7)b and to safeguard the health, safety and welfare of the public and to perform their duties under Saint Paul Legislative Code §34.19 by abating the nuisance storage conditions and hazards by seizing the items constituting the nuisance. Your Affiant's belief is based on his personal experience with the Property, his review of the STAMP file as well as his review of St. Paul Police Report, CN 15252263.

If property is as suspected, the Department of Safety and Inspections will issue all necessary and appropriate orders to abate the material endangerment secure the property and placard the condemned structures.

BASED UPON THE FACTS SET FORTH ABOVE, I hereby request on behalf of the Department of Safety and Inspections that an administrative search warrant be issued, commanding Steve Magner, and persons under his direction and a police officer escort, to search the premises at 1698 Lafond Avenue, City of Saint Paul, County of Ramsey, State of Minnesota between the hours of 8:00 a.m. and 8:00 p.m., in order to inspect the conditions at the subject premises, secure the property and post placards on any structures creating a material endangerment at the property and abate all public health, safety hazards and nuisance conditions found at the property.
