## NOTICE OF VIOLATION

Ernesto Reyes-Diaz La Fonda Mexican Eats 433 Robert Street South St. Paul, MN 55107

All licenses held by La Fonda, LLC d/b/a La Fonda Mexican Eats for the premises located at 433 Robert Street South in Saint Paul

License ID #: 20090002674

Dear Mr. Reyes-Diaz:

The Department of Safety and Inspections (DSI) will recommend adverse action against all licenses held by La Fonda, LLC d/b/a La Fonda Mexican Eats for the premises located at 433 Robert Street South in Saint Paul. The basis for the recommendation is as follows:

According to Department of Safety and Inspections (DSI) records, the initial liquor liability certificate you submitted when you applied for your licenses was cancelled by your insurance company for non-payment effective September 16, 2009. DSI never received a notice of that cancellation.

On September 7, 2010, you submitted a Certificate of Liquor Liability Insurance with a lapse in coverage. When DSI staff called your agent to verify the dates of the lapse, it was discovered that your lapse in coverage was from September 16, 2009 through August 10, 2010.

Therefore, per Saint Paul Legislative Code § 409.26 (b) (12) the licensing office will recommend a ten (10) day closure of your establishment for failure to comply with statutory and ordinance requirements for liability insurance.

At this time, you have two options on how to proceed:

- If you wish to admit the facts but contest the penalty, you may have a public hearing 1. before the Saint Paul City Council, you will need to send me a letter with a statement admitting the facts and requesting a public hearing. We will need to receive your letter by Monday, October 18, 2010. The matter will then be scheduled before the City Council for a public hearing to determine whether to impose the ten (10) day suspension of your licenses. You will have an opportunity to appear before the Council to make a statement on your own behalf.
- If you dispute the above facts, you can request a hearing before an Administrative 2. Law Judge. At that hearing both you and the City will be able to appear and present witnesses, evidence and cross-examine each other's witnesses. The St. Paul City Council will ultimately decide the case. If this is your choice, please advise me no later than Monday, October 18, 2010, and I will take the necessary steps to schedule the administrative hearing.

If you have not contacted me by that date, I will assume that you do not contest the ten (10) day suspension of your licenses. In that case, the matter will be placed on the Council's Consent Agenda for approval of the recommended penalty.
