In opposition:

Theresa Flynn, Executive Director of Clouds and Water Zen Center (308 Prince Street) expressed concern about the effects of loud ongoing construction, especially May 1 - 5 when the center was hosting a special guest and holding special events. She said the event had been planned over a year ago, and disruption of the event would reflect badly on the center and the City. She also expressed concerned about dust from the construction and about access to parking lots nearby.

Deneen Gannan, President of the Board of Directors of Tilsner Artists' Lofts, distributed a petition signed by residents of the Tilsner building and read a statement of opposition. She spoke about the effects of noise on residents who had already been affected by light rail construction and other development. She said they appreciated and were excited about development in the area, but the short term detrimental effects on quality of life and ability to sleep could not be understated. She said they questioned the timing corresponding with spring Art Crawl. She said they were not opposed to necessary construction but were requesting an alternate plan including daily overnight quiet hours.

Amy Bell (300 Broadway Street) said she believed the City was committed to the revitalization of downtown and to making it a desirable place to live as well as work. She suggested an alternate plan such as 16 hours a day for 18 days, ending at 10:00 p.m. each night.

Sam Chapirson (300 Broadway Street) pointed out how close the building was to the bridge, and said the building was old and not designed to dampen sounds. He said if construction went on all night no one would be able to sleep.

Councilmember Thune requested a response from staff to that concern.

John Maczko, Public Works, said no one from Lunda was present but the suggestions didn't sound unreasonable, and Public Works could work with the neighbors and contractor. He said they were able to adjust the light rail construction schedule and could do the same here. He noted that the contractor would not be hammering all the time.

Councilmember Thune said Public Works had been able to work on agreements between neighbors and contractors in the past. He moved to close the public hearing and adopt the resolution as amended.

Gary Evers, attorney with Shapiro and Zielke, said the property was being foreclosed by an investment trust that hadn't received any notifications except through his firm and Chase. He said the process was slow, and the lender hadn't provided him with information regarding what they wanted to do with the property. He asked what would happen if the conditions were met within a week, and whether the Council's decision was set in stone.

In response to questions from Councilmember Brendmoen, Mr. Evers elaborated on the foreclosure process and the steps that had been completed by the lender. He expressed frustration that he had not been able to get more timely or complete information from the lender, but stressed that they could not legally access the property to make improvements until the foreclosure was complete.

Councilmember Brendmoen asked Mr. Evers to estimate a sale price for the property. Mr. Evers said he hadn't seen the property and didn't know.

In response to questions from Councilmember Brendmoen, Ms. Moermond reviewed the history of hearings on the property.

Mr. Evers said his question had not been answered. Council President Lantry said what was before the Council was whether the building constituted a nuisance and should be demolished, and if circumstances changed after the Council had made a decision, Mr. Evers could contact Councilmember Brendmoen's office.

Councilmember Carter said it was unfortunate that the lender had not sent a more proactive message with Mr. Evers.

Legislative Hearing Officer Marcia Moermond said this would be the last time she would come before the Council asking for a layover for this property. She said it appeared that Eh Pooled 211 Lp had sold the property without providing the actual deed. She said the buyer was unable to pull permits and complete the rehabilitation without the deed, and had already sunk a lot of money on past due taxes and new roofing and siding. She said the buyer had gotten the services of an attorney who she hoped could help with the ownership paperwork. She asked that the public hearing be continued to May 15.

Councilmember Brendmoen thanked Legislative Hearing Officer Marcia Moermond for her work. She expressed concerns about the ongoing problem of nuisance properties being sold to unsuspecting buyers.

Councilmember Bostrom asked how the owner had been able to obtain permits for the work done so far. Ms. Moermond said her guess was that the permit desk hadn't checked the ownership records.

No one appeared in opposition; Councilmember Brendmoen moved to continue the public hearing to May 15.
