This resident came down to our office to dispute the late charges based upon the Periodic Notice of Non-Payment. He went to Public Works first and they said no you have to speak with some one in Office of Financial Services. He was very angry since our office is closed to the Public on Fridays so to calm him I said email me the paperwork and I will take care of the issue.

This parcel is his rental property at 652 Iglehart Ave.

From what I can tell and understand -

He received a Garbage Invoice from Republic Invoice date 10/5/2024 that shows a Previous Balance \$246.88/Payments/Adjustment -\$493.76/Current Invoice Charge \$246.88 then is states Total Amount Due \$0.00 this Invoice is for October to December 2024.

He receives another Republic Invoice date 10/5/2024 Past Due on 10/5/2024 \$246.88/Payment/Adjustments \$37.02/ Current Invoice Charges \$246.88 then it states Total Due \$530.78. The Invoice indicated 3 late charges on the Invoice (which I can only assume is for July -Sept) and then it says Current Invoice Charges, Due by October 25, 2024 \$246.88 (which I can only assume is for Oct-Dec). So why does this Invoice indicate that he owes \$530.78 which is for the previous billing cycle July to September 2024 \$283.90 and for the current billing cycle October to December 2024 \$246.88.

He then receives a Periodic Notice of Non-Payment on 10/5/2024, for Original Due Date of 7/31/2024, New Amount Due \$283.90.

Which now brings us to an email that Republic sent Dan Walsh on 7/23/2024 which states Thank you for your payment of \$246.88. Then on 8/16/2024 Daniel sent and email to Republic and PW Garbage stating he is not paying \$259.22 with a screen shot showing two 7/23/2024 payments of \$246.88.

At this point I told him our office would take care of correspondence with Public Works. Can we contact Republic and see what is going on with his account. No Late payments should have been added to the Previous balance for he made payment on 7/23/2024. Also it indicated that they received 2 payments of 246.88 so shouldn't he have had a credit towards his Oct to Dec billing cycle?

PO made 2 payments on 659 Iglehart instead of 1 payment on each property. He is now refusing to pay because he did send payment, but had overlooked the fact he didn't toggle between the two addresses while making the payment. He is also disputing late fees.

I believe PO is caught up in the Republic billing errors, and he will receive a new bill in a few days, but cannot confirm. I would email hauler, but this is out of my jurisdiction until January

Hi Dan

I handle all the garbage assessments for Saint Paul. Tanya sent me an email on October 11, explaining the issues you have with Republic Services. I have reached out to the to confirm the double payments at 659 Iglehart on three occasions and still have not heard back from them. I have also asked them to waive the late fees. As soon as I hear back about the late fees, and confirmation about the dual payments, I will let you know.

As for being told you are current at both addresses, that technically is correct (assuming you made a payment at 652 Iglehart during October). In the City of Saint Paul, garbage service is paid in advance on a quarterly basis. When bills are unpaid by the end of the billing cycle (three months), they are transferred to the City, who then pays the bill. This zeros out the account with the hauler and a pending assessment for delinquent garbage is placed on the property for the unpaid amount.

Let me know if this helps clarify information, and I will reach out again when I hear from Republic Services

I just gave you a quick call and left a VM, but I thought I would send you a short email as well.

Republic Services just responded stating they will remove the late fees from the assessment. I have processed the necessary documentation to have the assessment reduced on the Saint Paul Assessment portal. It typically takes a few days to have the adjustment reflect online. The late fees were a total of \$37.05, so once everything is updated, your new assessment amount will be \$246.88.

Again, I am sorry this has been such a frustrating situation. One thing to note is the city of Saint Paul will be handling all garbage billing in April 2025, and things will run a lot smoother once we take over.

I got your message that they "waived" the late fees as they should have as there was never a late payment, just two payments under 1 address. That was again identified on August 16th once the first letter was sent out. The money was always in Republics accounts as of July 23rd 2024.

So I am confused as to this "The late fees were a total of \$37.05, so once everything is updated, <u>your new</u> assessment amount will be \$246,88."

The money for Q3(paid on July 23rd 2024, and now Q4(withdrawn from my bank pic below) have all been paid. So there should be no assessment?

Hi Dan

I was able to verify more information with Republic. They did receive your check and cashed it. Half of the check was used for the Quarter 4 bill at 652 Iglehart, and the other half went towards 659 Iglehart, prepaying the Quarter 1 2025 billing, since you already had a credit on that account.

I understand that was probably not your intention, but the City already paid your Quarter 3 2024 balance off with Republic Services on October 1, which reset your account with Republic Services (placing it to a \$0 balance). On October 5, your accounts had standard quarterly charges applied to it. It is done this way in Saint Paul to prevent an interruption of trash service due to non payment.

The Balance is still due to the City for 652 Iglehart. I also recommend only paying for 652 Iglehart on January, since you prepaid for 659 Iglehart.

In April, our contract ends with Republic services, and we will take over all of the billing from that point forward. We know that shifting the billing to the City will simplify things.

There are two ways to pay your garbage assessment:

- Pay online using the Assessment Payment Portal at <u>stpaul.gov/assessments</u>. You can use a check, debit, or credit card.
- Mail a check (written out to CITY OF ST PAUL ASSESSMENTS) and send it to:

Hi Dan

We did receive the email on August 16, but as we stated in earlier correspondence, we do not have access to Republic's billing system. Because you did not successfully resolve the billing issue with Republic Services prior

to the quarter's end, your address was assessed along with all delinquent accounts at the end of the Quarter 3 2024. The delinquent account list only has addresses, names, and amount due. There are no notes included, and even if there were notes, the notes on 652 Iglehart would have been limited since the double payment happened on 659 Iglehart.

I have reached out to ask for the funds from 659 Iglehart to be transferred over from Republic Services to cover the Quarter 3 assessment for 652 Iglehart. I have not received confirmation yet, but as soon as I hear back, I will let you know. Doing this will remove your prepayment for the Quarter 1 2025 billing at 659 Iglehart, and you will owe for both addresses in January. This means the information in my previous email will no longer be correct.
