



## Proposed Rose Avenue Vacation Description

That part of Rose Avenue dedicated in the plat of EVANS ADDITION TO THE CITY OF SAINT PAUL, according to the recorded plat thereof, Ramsey County, Minnesota, lying westerly of Greenbrier Street and lying easterly of a line described as commencing at the southeast corner of Block 1, said EVANS ADDITION TO THE CITY OF SAINT PAUL; thence on an assumed bearing of South 88 degrees 57 minutes 22 seconds West along the south line of said Block 1, a distance of 257.05 feet to the point of beginning of the line to be described; thence southwesterly a distance of 78.69 feet along a tangential curve concave to the southeast having a radius of 50.00 feet and a central angle of 90 degrees 10 minutes 26 seconds; thence South 00 degrees 56 minutes 13 seconds East, not tangent to said curve, a distance of 9.83 feet; thence southerly a distance of 6.03 feet along a tangential curve concave to the east having a radius of 50.00 feet and a central angle of 6 degrees 54 minutes 45 seconds to the north line of Block 2, said EVANS ADDITION TO THE CITY OF SAINT PAUL and said line there terminating.


