**Event:** WCCO Television Pulling Together Event 2017

**Description of Variance:**

**Location:** Hidden Falls Regional Park and Mississippi River Boulevard

**Noise Source:** WCCO Television has requested a sound level variance, at no specified sound level limit or distance, to provide the use of a sound system for amplified music and announcements at Hidden Falls Regional Park and Mississippi River Boulevard for the 2017 Pulling Together Event. The variance is requested for the hours of 9:00 a.m. to 3:00 p.m. on Saturday, June 10, 2017, with a Rain Back up Date of June 11, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 9:00 a.m. to 3:00 p.m. for the Pulling Together Event on Saturday, June 10, 2017, with a Rain Back up Date of June 11, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. The applicant may need to provide a barrier, to act as a sound absorber, to contain excess sound from leaving the area 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 3:00 p.m. on the date of the event.
