The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **August 15, 2024** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

1. SPLC 34.09. - **DECK/STAIRWAY:** Repair or replace the unsafe stairways, porch, decks, guardrails, and handrail in a professional state of maintenance and repair. This work requires a permit(s). Call DSI at (651) 266-9090.

PLEASE REMOVE, REPAIR OR REPLACE THE FAILED REAR DECK AND BACK PORCH TO MEET CODE.

2. SPLC 34.09. - **EAVES:** The eaves and soffits are in a state of disrepair or deterioration. Repair all defects, holes, breaks, loose or rotting boards, to a professional state of maintenance. Permit may be required.

PLEASE REPAIR ALL LOOSE OR ROTTING WOOD AND PAINT.

3. SPLC 34.09. - **EXTERIOR WALLS:** The exterior walls and/or trim of the house and/or garage has defective or peeling paint, or unpainted wood surfaces. Maintain in a professional state of maintenance and repair.

PLEASE SCRAPE ALL PEELING PAINT AND RE-PAINT THE HOME TO PROTECT THE WOOD FROM THE ELEMENTS.

4. SPLC 34.09. - **WINDOWS:** Repair and maintain the window in good condition including the glass, sash, frame, and screens. Windows shall be without cracks or holes, sashes shall be in sound conditions, the window shall be easily opened and maintain the open position. All screens shall be maintained in a professional state of maintenance and repair.

PLEASE REPLACE ALL TORN OR MISSING SCREENS AND REPLACE ALL MISSING WINDOWS. THANKS

**As owner or person(s) responsible for : 327 MAPLE ST you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.**

1. Remove improperly stored or accumulated refuse which may include: garbage, rubbish, loose and scattered litter, discarded furniture, appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from entire property including yard, boulevard, alley, and driveway.

PLEASE REMOVE AND PROPERLY DISPOSE OF TREE AND BRUSH TRIMMINGS, CAR PARTS, TIRES, BUCKETS, WOOD, PAINT CANS, TRASH, DEBRIS, FROM THE PROPERTY, INCLUDING THE REMOVAL OF ALL THE ROCKS, BRICKS, AND POTS FROM THE BOULEVARD, PROPERTY, AND PARKING PAD AREA.  
 THANKS Comply before August 23, 2024

2. Cut and remove tall grass, weeds and rank plant growth from yard, blvd, and alley areas.  
 CUT AND REMOVE TALL GRASS, WEEDS AND RANK PLANT GROWTH FROM YARD, PARKING PAD AREA, BOULEVARD AND ALLEY AREAS. THANKS Comply before August 23, 2024

3. SPLC 105. - BOULEVARD PLANTING: Cut/trim or remove and properly dispose of any plantings in violation of Chapter 105. (Additional requirements in Chapter 45)
  - 1) Plantings must be maintained in such a way that there is no overhang or encroachment onto the sidewalk, curb, or street area.
  - 2) Plantings may not exceed thirty- six (36) inches in height.
  - 3) Plantings within thirty (30) feet of any intersection may not exceed eighteen (18) inches.
  - 4) Plantings within five (5) feet of any alley or driveway may not exceed eighteen (18) inches.
  - 5) Plantings within ten (10) feet of street sections that do not have parking lanes may not exceed eighteen (18) inches.

PLEASE CUT, TRIM OR REMOVE ALL BOULEVARD PLANTINGS TO MEET THE ABOVE RESTRICTIONS.  
 Comply before August 23, 2024

If you do not correct the nuisance or file an appeal **before August 23, 2024** , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.
