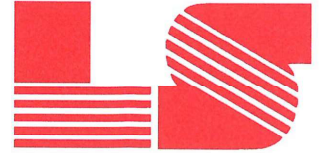

Subject: Sound level variance description

To whom it may concern:

Lametti and Son's has a contract to perform construction rehabilitation work for the City of St. Paul Sewer department. The work will be performed at the intersection of 4th St East and Commercial St.

Overnight work will be performed from 10pm to 1 am Monday through Friday. The majority of work will be performed underground in the storm sewer tunnel system. There may be a need to start and run a skid steer or a loader to service the construction activities. The intention of Lametti is NOT to run equipment at night but this permit application is in the case we need to.

To finish the project in the time allotted a night shift will need to be utilized from the beginning of the project (beginning of December) to the end of the project (end of March).

The access to the tunnel and the possible source of noise will be at the south east corner of 4th St East and Commercial St.
