Dear Mr. Getty:

This is to confirm that on July 13, 2021 at the Legislative Hearing, Marcia Moermond, the Legislative Hearing Officer recommended that the City Council:

1. **Find that the nuisance is not abated** and there was **not compliance** with the May 12 vehicle abatement orders for the Mitsubishi. The department of safety & inspections can take steps to abate the nuisance after the City Council Public Hearing on July 21, 2021; and
2. **Grant to July 23, 2021 for compliance** with the June 30, 2021 Summary Abatement Order.

The City Council Public Hearing is scheduled for July 21, 2021 at 3:30 p.m. Due to the COVID-19 pandemic, **we will not be holding hearings in person.** If you are contesting Ms. Moermond's recommendation, you may send written testimony to be added to the record to [legislativehearings@ci.stpaul.mn.us](mailto:legislativehearings@ci.stpaul.mn.us) or by voicemail at 651-266-6805. If you don't wish to contest, no further action is needed.

After the July 21 hearing, a making finding resolution will be scheduled for **July 27, 2021 at 11:00 a.m. via phone** to determine if the nuisance is abated on deadline. The public hearing on that is **July 28, 2021 at 3:30 p.m.** Again, due to the COVID-19 pandemic, **we will not be holding hearings in person.** If you will be contesting Ms. Moermond's recommendation, you may send written testimony to be added to the record to [legislativehearings@ci.stpaul.mn.us](mailto:legislativehearings@ci.stpaul.mn.us) or by voicemail at 651-266-6805. If you don't wish to contest, no further action is needed.
