I've copied your inspector here; please work with Inspector Vue on your Certificate of Occupancy requirements.

If your Certificate of Occupancy isn't reinstated by March 1 the property will go back into the Vacant Building program, you can choose not to pay that fee and let it go to assessment and then **appeal that assessment (which is free and totally fine to do)**, and you can speak with the hearing officer about prorating that Vacant Building fee for your time in the program. Ms. Moermond won't waive the Vacant Building fee longer than 90 days.
