Description of Variance:

Location: Upper Landing Park

Noise Source: Anderson Race Management has requested a sound level variance to provide the use of a sound system for announcements and 11-piece band at Upper Landing Park for the Abria Life is Wonderful 5K and Family Walk. The variance is requested at a sound level limit of 90 decibels (dBA), at no specified distance, for the hours of 9:00 a.m. to 12:00 p.m., with a pre-event sound check at 8:00 a.m. on Saturday, May 13, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) the variance shall be for the hours of 9:00 a.m. to 12:00 p.m., with a pre-event sound check at 8:00 a.m., for the Abria Life is Wonderful 5K and Family Walk on Saturday, May 13, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. on the date of the event.

If you attend the public hearing, you will be given the opportunity to present verbal comments or objections before the City Council.
