NOTICE OF PUBLIC HEARING

Team Ortho Foundation – Monster Dash Sound Level Variance - Shepard Road and Randolph Median

TO: West Seventh/Fort Road Federation

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: Shepard Road and the Randolph Median

Noise Source: Team Ortho Foundation has requested a sound level variance to provide the use of a mobile DJ sound system for runners for the Monster Dash Event. The variance is requested for the hours of 9:00 a.m. until 12:00 p.m., with a pre-event sound check at 8:45 a.m. on Shepard Road and the Randolph Median on Saturday, October 31, 2015. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 9:00 a.m. to 12:00 p.m., with a pre-event sound check at 8:45 a.m. on Shepard Road and the Randolph Median on Saturday, October 31, 2015. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. on the date of the event.
