NARRATIVE

On 2/3/2017, I (Kosloske) assisted with the execution of a search warrant at the Red Wok Sushi, located at 1626 White Bear Ave No., in St. Paul, MN. Upon entering the business, the premises and individuals were secured and detained with the assistance of other Officers. All individuals present at the time the S/W was executed were identified. One of the subjects of this investigation, Futchy LY, was present at the time and detained.

Within a short time, suspected controlled substances and a large amount of U.S. Currency was found. At this time, I was asked to try to interview Futchy LY. LY was handcuffed and I had him come to a different table within the restaurant that was not withing ear or sight of customers and family that were present in the restaurant.

I advised LY of his Miranda Rights, which I read from SPPD Form 247.1-95R. Since he was handcuffed, I did not have him sign the form. After reading him each paragraph I asked if he understood. Each time he acknowledged that he understood. He also was willing to talk to me. The following is a synopsis of that interview and is not meant to be a transcript.

We began by talking about the restaurant. He said he owns it with his brother. He said he is Hmong. He said he knew why we were here. I told him we found drugs and he said he knew that. He said he uses drug once in a while. He said he uses cocaine when he's drinking. I asked him how much cocaine he had at the business here today? He said he had one key (referring to 1 kilo) in the safe. I asked if he had marijuana and LY said that he knows that we have some here, but his brother might. I asked how much he paid for the kilo. He said about \$34,000.00. He said he deals with Mexicans and they bring it here. I asked about his brother and he said his brother deals with the marijuana. He said they sell the cocaine and the marijuana. He said they will sell a one or two pounds of marijuana. I asked if they sell the cocaine too. He said they did. He said they will sell a kilo and they will sell it by the ounce. I asked about the cash found. He said the cash was from the restaurant. He said the money was in a safe with the cocaine. We talked for several more minutes about what would be happening from this point and the near future.
