Your building was inspected on November 15, 2013 for the renewal of your Fire Certificate of Occupancy. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected prior to the re-inspection date. **A re-inspection will be made on or after December 15, 2013.**

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

DEFICIENCY LIST

1. SPLC 34.11 (6), 34.34 (3) - Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office. **THIS MUST BE COMPLETED BY DECEMBER 15, 2013.**

2. SPLC 34.08 (3) - Provide and maintain suitable ground cover on all exterior areas to control erosion. Provide approved ground covering in the yard. **THIS MUST BE COMPLETED BY JUNE 1, 2014.**
3. Have the permit for the new deck finalized and approved. Obtain the required permit for the new fence installation. -Contact DSI at 651-266-8989. **THIS MUST BE COMPLETED BY DECEMBER 15, 2013.**
4. SPLC 34.08 (7) - All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-8989. **THIS MUST BE COMPLETED BY JUNE 1st 2014, OR AN APPEAL MUST BE FILED WITHIN 10 DAYS OF THIS NOTICE.**

You have the right to appeal these orders to the Legislative Hearing Officer.
