Location: Shepard Road under the Smith Avenue Bridge

Noise Source: Team Ortho Foundation has requested a sound level variance in order to provide use of a sound system for announcements and amplified outdoor music on Shepard Road under the Smith Avenue Bridge for the Monster Dash Event. The variance is requested for the hours of 9:00 a.m. until 12:30 p.m., with a pre-event sound check at 8:45 a.m. on Saturday, October 29, 2016. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 9:00 a.m. to 12:30 p.m., with a pre-event sound check at 8:45 a.m. for the Event on Saturday, October 29, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 80 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:30 p.m. on the date of the event.

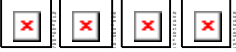
