Your building was inspected on September 16, 2010 for the renewal of the Fire Certificate of Occupancy and was approved. When the required fee has been paid you will receive your certificate. There are however seasonal or non-life safety deficiencies noted below which must be corrected prior to re-inspection.

The following deficiencies must be corrected immediately. A reinspection will be made on October 13, 2010 at 9:30 am.

#### DEFICIENCY LIST

- Front Stairway to 2nd Floor SPLC 34.10 (3), 34.33(2) Provide an approved handrail. The top of the handrail must be between 34 and 38 inches above the treads and run the entire length of the stair. - Provide an approved 1. handrail for lower flight of stairs.
- Front Stairway to 2nd Floor SPLC 34.10 (3), 34.33(2) Repair or replace and maintain an approved guardrail. -Provide an approved guardrail across stair landing. Height of current guardrail is 16.5 inches high above landing. 2. Height from landing to floor is 48 inches.

You have the right to appeal these orders to the Legislative Hearing Officer. Applications for appeals may be obtained at the Office of the City Clerk, 310 City Hall, City/County Courthouse, 15 W Kellogg Blvd, Saint Paul MN 55102 Phone: (651-266-8688) and must be filed within 10 days of the date of this order.
