DSI will only issue separate licenses within a single building, if each business entity is located within it on self contained space(e.g. separate repair facilities not requiring shared use between tenants and separate sanitary, and other utility services, etc.) Cha agreed to hold the business licenses and maintain responsibility for the business activity.
