## **NOTICE OF PUBLIC HEARING**

### Sound Level Variance

### Lucky Palooza on West 7<sup>th</sup> -Visit Saint Paul

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

#### **Description of Variance:**

**Location:** The Lucky Palooza Event will take place on a closed portion of 7<sup>th</sup> Street West between Kellogg Boulevard West (174 7<sup>th</sup> Street West) and Walnut Street North (258 7<sup>th</sup> Street West) on March 9, 2019.

**Noise Sources:** Visit Saint Paul has applied for a sound level variance in order to provide amplified outdoor music using electronically powered equipment at the recommended locations, times and decibel level limits (dBA) described below: 1) The Variance shall be for the hours of 2:00 p.m. until 11:00 p.m. in the street on West 7<sup>th</sup> Street on March 9, 2019 outside Tom Reid's, 258 7<sup>th</sup> Street West and at Eagle Street/The Liffey, 174 7<sup>th</sup> Street West, under the overhang in front of Cossetta's, 211 7<sup>th</sup> Street West and for a Mechanical Bull Sound System outside of Hampton Inn & Suites, 200 7<sup>th</sup> Street West; and in fully enclosed tents from 2:00 p.m. on March 9, 2019 until 1:00 a.m. on March 10, 2019 for a DJ/Live Music from tents at Burger Moe's Parking Lot, 242 7<sup>th</sup> Street West, Cossetta's Parking Lot, 211 7<sup>th</sup> Street West, and in McGovern's Parking Lot, 225 7<sup>th</sup> Street West during the Lucky Palooza Visit Saint Paul Event. 2) All electronically powered equipment used in conjunction with the event shall not exceed 95 dBA as measured at 50 feet from the sound sources outside on the street from 2:00 p.m. until 11:00 p.m. on March 9, 2019, and not exceed 80 dBA as measured at 50 feet from the sound source outside of the fully enclosed tents from 11:00 p.m. on March 9, 2019 until 1:00 a.m. on March 10, 2019.
