

## Federal Funding Sources



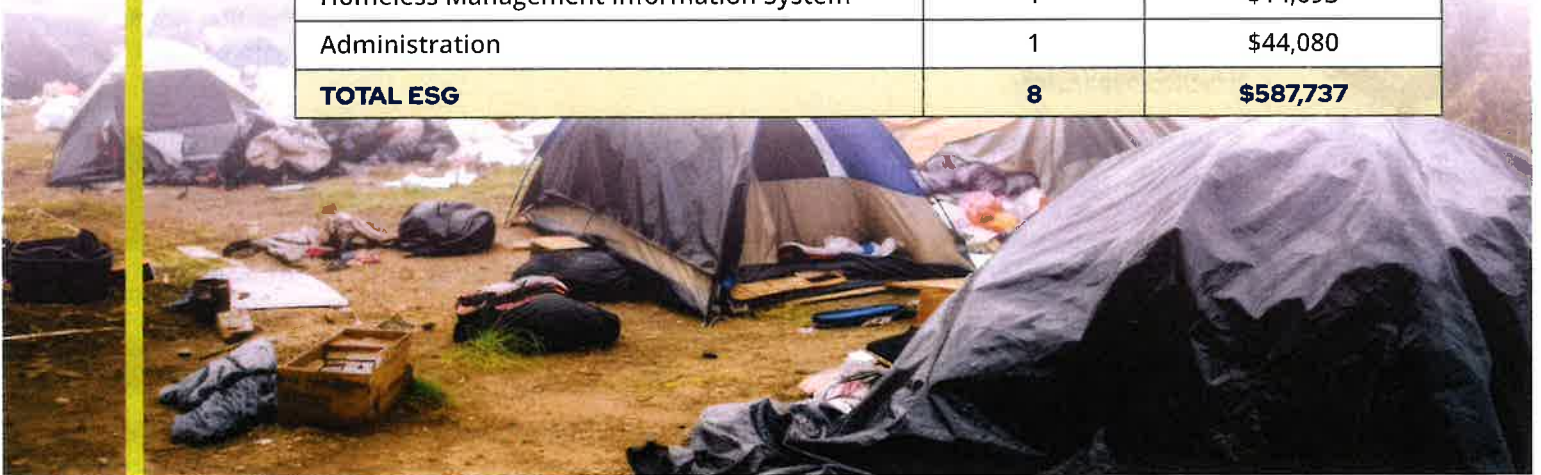
**The U.S. Department of Housing and Urban Development (HUD) Continuum of Care (CoC) Program** is a competitive but dependable grant program, usually annual, for CoC projects. These funds cannot be used for emergency shelter. Heading Home Ramsey applies through a collaborative application for project-specific grant agreements between HUD and individual providers.

**The HUD Emergency Solutions Grant (ESG)** is formula funding allocated to the City of Saint Paul and currently administered by Ramsey County Housing Stability through a joint powers agreement between the City and County, in coordination with Heading Home Ramsey. Up to 60% of these funds can be used on Street Outreach and Shelter Operations.

**The Minnesota Department of Human Services (DHS) Office of Economic Opportunity (OEO) recently merged into a new Homelessness, Housing, and Support Services Administration (HHSSA).** HHSSA administers multiple grant programs through a biennial request for proposals. These, are listed below along with total funding granted directly to providers in Ramsey County.

**MN Housing's Family Homeless Prevention and Assistance Program (FHPAP)** is granted primarily to counties and tribal nations on a formula basis for the program categories below and is administered by Ramsey County Housing Stability in coordination with Heading Home Ramsey. This biennium's funding was allocated in four tranches that must be managed and tracked separately.
