Please take notice that this matter has been set on the Public Hearing Agenda for the City Council meeting has been scheduled for **Wednesday, November 2, 2011 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse.

This is an uncontested matter concerning the fact that during a re-inspection of your licensed premises on September 12, 2011, a DSI Inspector cited you for the same Critical-Major Environmental Health Code violation that had not been corrected by the August 28, 2011 deadline.

Therefore, the licensing office will recommend a \$250.00 matrix penalty and suspension of your licenses until the violation is corrected.




