Amending Chapter 64 of the Legislative Code pertaining to nonconforming signs.

Councilmember Tolbert introduced an amendment to 64.301c "grandfathering" current billboard extensions, which would become non-conforming uses if they were altered.

Council President Lantry clarified that all billboards were nonconforming uses currently and had been for many years.

In response to questions from Councilmember Thune, Councilmember Tolbert and Council President Lantry clarified the Planning Commission language relating to temporary extensions and the change being proposed by Councilmember Tolbert. Council President Lantry noted that the amendment reverted to language from ten years ago - before extensions were outlawed - and she said she would be speaking against the amendment.

In response to a request for clarification from Councilmember Carter, Councilmember Tolbert said the amendment would apply to approximately 15 to 20 existing extensions, and to the extensions themselves, not the ads on the extensions.

In response to a question from Councilmember Stark, Council President Lantry confirmed that the amendment meant that, in addition to the temporary extensions, the existing 20 or so would be permanent.

Councilmember Brendmoen said she was not clear on what was being proposed and she suggested holding the public hearing. Deputy City Attorney Gerald Hendrickson said the public hearing could be held before or after a vote was taken on the amendment. He said the proposed change was substantive and would require another public hearing if it was not voted on during the current meeting. Council President Lantry said the public could comment on the ordinance and proposed change since the amendment language was available and had been discussed.

Councilmember Tolbert said he was fine with hearing testimony before the vote on the amendment.

Testimony:

Tom McCarver, Clear Channel Outdoor (3225 Spring Street, Minneapolis), said the proposed permit fee for extensions was the first permit fee in Minnesota. In response to Council President Lantry's comment that the amendment was the same as language from 10 years before, Mr. McCarver said it was new language because times had changed. He said they supported language that regulated, and their only problem was with the duration limits of 90 days or 180 days total. He proposed limiting the number of signs instead. He distributed sample language.

Councilmember Brendmoen asked why they opposed the 90 day time limit. Mr. McCarver said advertisers, including many local businesses, invested a lot for extensions. He noted that the City had essentially been operating without an extension ordinance for four years without any complaints. Councilmember Stark asked how many signs they were proposing. Mr. McCarver said there were two companies in St. Paul for off-premise billboards - Clear Channel and CBS and their proposal was that no more than 30 faces would have extensions at one time. Council President Lantry confirmed that was 30 per company, and asked what would happen if more companies came in. Mr. McCarver said CBS and Clear Channel were strong companies and, in any case, there couldn't be more signs. He clarified that it applied only to signs on freeways.

Jean Weigman (1647 Laurel Avenue) said the sign companies wanted this because it gave them more valuable billboards by increasing the space for advertising. She said when a property was being redeveloped and had a billboard on it, the cost to take the sign down was usually borne by the tax payer. She said some recently installed digital billboards would need to be removed due to road changes, and the cost was between \$2 to \$4 million per digital billboard. She said redevelopment projects were being held up now because of the cost of removing billboards, and approval of the amendment and ordinance would mean 60 more costly billboards to take down. She said the ordinance represented a serious anti-development initiative and she urged the Council to resist it.

Ossian Or (1600 Portland Avenue) expressed his dislike for the billboard at Snelling (and I-94), and questioned Mr. McCarver's assertion that Clear Channel was strong and not going anywhere. He said the language for the amendment had come from the billboard industry and not from Councilmember Tolbert, and the billboard industry wasn't offering anything in return.

Councilmember Thune moved to close the public hearing. Yeas - 7 Nays - 0

Councilmember Tolbert moved the amendment.

Councilmember Stark said the Planning Commission language already represented a compromise and he would not support the amendment.

Councilmember Carter agreed that the current language current language was a compromise and met the needs expressed.

Councilmember Brendmoen said she was surprised there was not more of a consensus given the number of times the item had been laid over, and an effort should be made to come to an agreement.
