Chair Miller read the purpose statement. David Eide presented a staff report with a recommendation of approval based upon findings one through six. He noted that staff did not receive a recommendation from Hamline Midway Coalition, and no correspondence was received.

No one spoke in support or opposition. George Wojcicki of Xcel Energy Siting and Land Rights Group, 414 Nicollet Mall, Minneapolis, Minnesota, 55401, spoke about the project.

Chair Miller asked if anyone was present to speak for or against the request. Nobody stepped forward.

The public hearing was closed.

Dayton moved approval of the request. Schweitzer seconded. Maxine Linston conducted a roll call vote with Martinson, Dayton, Schweitzer, and Miller voting to approve the request based upon the staff findings.

# 889 Iglehart Avenue

Chair Miller read the purpose statement. David Eide presented a staff report with a recommendation of denial based upon findings three, four, and six. He noted that staff did not receive a recommendation from District 8 – Summit-University Community Council. Two letters were received opposing the request.

Chair Miller called the applicant forward. Stephanie Goode, 87 Kent Street, and Michael Beltowsky, 6745 Harriet Avenue of Horowitz Health representing the applicant, Horowitz Health, came forward and spoke about the request and answered questions from the Board.

Mark Schwartz, 461 Arlington Avenue West, spoke in support of the request. Greta Grosch, 885 Iglehart Avenue, spoke in support of the request. Rasheen Tillman, 894 Iglehart Avenue spoke in opposition to the request. Deanna Strother, 667 St. Anthony Avenue, and Antonio Strother, 667 St. Anthony Avenue, spoke in opposition to the request. Jacob Southworth, 868 Carroll Avenue, spoke in opposition to the request. Allison Pederson, 768 Goodrich Avenue, stepped forward to ask guestions.

Stephanie Goode for the applicant came forward to respond to the public comment.

City Attorney Dan Stahley stated that if the Board chooses to find contrary to the staff recommendation that the matter be laid over to allow CAO additional time to draft alternate findings.

Schweitzer asked about reopening the public hearing to ask additional questions of the applicant. Martinson moved to suspend the rules to allow for the public hearing to re-open. Schweitzer seconded. Martinson, Dayton, Miller, and Schweitzer voted yes to re-open the public hearing.

The board asked additional questions of the applicant's representative.

Bill Dermody of Planning and Economic Development stepped forward to explain the code amendment timeline. Chair Miller closed the public hearing.
