Revocation of Fire Certificate of Occupancy and Order to Vacate

RE: 581 COMO AVE

Dear Property Representative:

Your building was inspected on September 19, 2017, for the renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code.

A re-inspection will be made on October 18, 2017 at 2:30 PM or the property vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

DEFICIENCY LIST

1. Exterior - Garage - SPLC 34.08(5), 34.32(3) - All accessory structures including, but not limited to, detached garages, sheds and fences shall be maintained structurally sound and in good repair. Provide and maintain exterior unprotected surfaces painted or protected from the elements.-The garage still has some siding that is in disrepair, openings in the fascia, the main garage door is damaged and not well maintained, and other damages.
2. Exterior - Parking Surfaces - SPLC 34.08 (7) - All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-9090.-Maintain the Class 5 gravel for the back parking space area. The patching for the asphalt driveway is not complete.

3. **SPLC 40.06 - Suspension, revocation and denial. (A) Grounds for revocation. The fire code official may, in writing, issue a notice to the owner(s) and know interested parties of the city's suspension or revocation of a fire certificate of occupancy issued under the provisions of this code, or deny an application therefor:
(3) If it is found upon inspection of the fire code official that the building or occupancy is in violation of provisions of this or other applicable safety codes, ordinances, rules and regulations;
The Certificate of Occupancy has been revoked due to long term non-compliance.**
4. SPLC 39.02(c) - Complete and sign the smoke detector affidavit and return it to this office.

You have the right to appeal these orders to the Legislative Hearing Officer.
