- 2. Exterior - S porch - SPLC 34.09 (2), 34.32(2) - Repair or replace the unsafe stairways, porch, decks or railings in an approved manner. This work may require a permit(s). Call DSI at (651) 266-9090. - Repair, replace, or remove porch with approved building permits. The porch is pulling away from the house.
- Exterior Ext. Door SPLC 34.09 (3), 34.33 (3) Repair and maintain the door in good condition. Repair or replace the screen door on the front porch.
