Dear Navid Amini:

As discussed with staff on – site today, the Legislative Hearing officer’s recommendation is to **grant to September 1, 2025 for compliance with the following:**

1. To contact [Met Council](#) to confirm whether a sewer access/availability charge is due for this change of use, and if so fee paid (whether that is by you or the property owner is at your discretion); and
2. Application for [change in use should be made using a building permit](#), specifying it is for change in use (from mercantile to business), sent to attention of: Melissa Doody.
  - a. This should include diagram of the space including measurements (this will also be needed for SAC if required)
  - b. It isn’t anticipated there will be any changes required for your location, but if so, staff will let you know.

This matter will go before the City Council at Public Hearing on **Wednesday, April 16, 2025 at 3:30 pm. in room 300 City Hall.** If you are contesting Ms. Moermond’s recommendation you may:

1. appear in person (*please arrive before 3:30 p.m. and check in with staff outside Council chambers when you arrive*); or
2. **Should you wish testify to Council directly by phone, you must register to do so online by no later than noon on Tuesday, April 15, 2025 here:**

If you don’t wish to contest then **no further action is needed** and the Council will proceed with Ms. Moermond’s recommendation above without discussion. If you have any questions, please contact our office at 651-266-8585.
