We do not show any history for 847 York ave where you asked for carts to be removed, or calling and stating the carts went missing. Because we did not know there was a missing cart, you were charged for bags. Do you happen to know when the carts went missing?

I also show that we delivered a medium cart recently. In the delivery photo, it shows three carts at the property now. It appears the second large cart was not missing since we do not have record of it being delivered to 847 York (I do have record of a large cart being delivered to 841 York).

Thank you for your assistance in this matter.

We own both 847 York and 841 York - it has been very difficult keeping the trash cans in place and picked up - we did have to call a few times to get cans emptied over the last few months. Regarding 847 York, we are paying for three containers for a duplex - so if the trash was picked up on time with three cans, we should never have extra bags.

There have been pick up and trash can issues since the city took over the trash collection.

It appears that the issues causing the problems have been corrected.

Now we are just asking for the city to credit us for the extra bags on the last two billing cycles.

Extra bags are \$4.25 each, plus taxes and fees. If garbage bags are present in or next to your cart, it is not possible for us to remove the charges. If you believe there was an error, please respond to this email.

**Please note extra bag fees are applied whenever the lid is open by six inches or more; and large overages or oversized bags will count as more than one bag.
