UPON PROJECTION OF FULL REPAIR, ENABLE RESEARCH TO CONCLUDE ANSWER FOR ACTUAL (HOME) AND CHOICE TO RETURN OR RE-TITLE THE CITIZEN.

SET ALL LAWS TO CONCLUDE ASSURED... SUCH INFRINGEMENTS DO NOT RE-OCCURE.



# A BRIEF HISTORY OF ENSLAVEMENT & APARTHEID TIMELINE

TIMES AND DESCRIPTION OF ENSLAVEMENT HISTORIC LEADING TO CASE FOR REPARATIONS

- 1539** HERNANDO DE SOTO, FOLLOWING REPORTS FROM CABEZA DE VACA, LANDS ON THE COAST OF FLORIDA.
- 1661** THE FIRST ANTI-MISCEGENATION STATUTE - PROHIBITING MARRIAGE BETWEEN RACES - WAS WRITTEN INTO LAW IN MARYLAND IN 1661, SHORTLY AFTER ENSLAVED PEOPLE WERE BROUGHT TO THE COLONIES.
- 1712** OF ABOUT 1200 MEN IN HIS EXPEDITION, AROUND 50 WERE AFRICAN SLAVES.
- 1712** AN UPRISING OF ENSLAVED PEOPLE TAKES PLACE IN NEW YORK. EIGHT WHITE COLONISTS ARE KILLED AND MANY BUILDINGS BURNED DOWN.
- 1737** IN PHILADELPHIA, BENJAMIN FRANKLIN PUBLISHES ALL SLAVE-KEEPERS THAT KEEP THE INNOCENT IN BONDAGE, APOSTATES AN ANTISLAVERY TRACT WRITTEN BY THE PENNSYLVANIAN QUAKER BENJAMIN LAY.
- 1776** THE DECLARATION OF INDEPENDENCE, WHICH EMBRACED IN ITS FIRST LINES "THAT ALL MEN ARE CREATED EQUAL, THAT THEY ARE ENDOWED BY THEIR CREATOR WITH CERTAIN UNALIENABLE RIGHTS", DID NOT EXTEND THAT RIGHT TO SLAVES, AFRICANS OR AFRICAN AMERICANS, WITH THE FINAL VERSION SCRAPPING A REFERENCE TO THE DENUNCIATION OF SLAVERY.
- 1793** A YOUNG YANKEE SCHOOLTEACHER NAMED ELI WHITNEY INVENTED THE COTTON GIN, A SIMPLE MECHANIZED DEVICE THAT EFFICIENTLY REMOVED THE SEEDS.
- 1820** A BITTER DEBATE OVER THE FEDERAL GOVERNMENT'S RIGHT TO RESTRICT SLAVERY OVER MISSOURI'S APPLICATION FOR STATEHOOD ENDED IN A COMPROMISE MISSOURI WAS ADMITTED TO THE UNION AS A SLAVE STATE, MAINE AS A FREE STATE AND ALL WESTERN TERRITORIES NORTH OF MISSOURI'S SOUTHERN BORDER WERE TO BE FREE SOIL.
- 1850** ANOTHER TENUOUS COMPROMISE WAS NEGOTIATED TO RESOLVE THE QUESTION OF SLAVERY IN TERRITORIES WON DURING THE MEXICAN-AMERICAN WAR.
- 1865** ACCORDING TO ABRAHAM LINCOLN, THE CIVIL WAR WAS FOUGHT TO KEEP AMERICA WHOLE, AND NOT FOR THE ABOLITION OF SLAVERY - AT LEAST INITIALLY. SOUTHERN STATES SAID THEY WANTED TO SECEDE TO PROTECT STATES' RIGHTS, BUT THEY WERE REALLY FIGHTING TO KEEP PEOPLE ENSLAVED.
- 1898** THE RECESSION OF THE LATE 19TH CENTURY HIT THE US. KNIGHT RIDERS WENT OUT IN THE DARK, BURNING THE HOMES OF AFRICAN AMERICANS WHO BOUGHT THEIR OWN LAND.
- 1926** AS AFRICAN AMERICANS WERE SHUT OUT OF JOBS AND OPPORTUNITIES DURING JIM CROW, AND AS MORE JOBS BECAME AVAILABLE IN THE NORTH AND MIDWEST, MORE THAN 2 MILLION SOUTHERN AFRICAN AMERICANS MIGRATED AFTER THE FIRST WORLD WAR
- 1948** GENERAL ASSEMBLY OF THE UNITED NATIONS ADOPTS UNIVERSAL DECLARATION OF HUMAN RIGHTS. ARTICLE 4 STATES: 'NO ONE SHALL BE HELD IN SLAVERY OR SERVITUDE; SLAVERY AND THE SLAVE TRADE SHALL BE PROHIBITED IN ALL THEIR FORMS.'
- 1965** UNITED STATES OF AMERICA CONTINUED SLAVERY BY WAY OF APARTHEID WITH A MASK LABELED JIM CROW LAWS
- 2022** SLAVERY AND APARTHEID STILL EXISTS IN THE UNITED STATES OF AMERICA WHILE ITS PERPETRATORS AND BENEFICIARIES HAVE FORMED EXCUSES, BACKLASH, AND LACK OF WILL TO DIMINISH

Hi. I just wanted to voice my opinion on reparations. I guess there's a meeting coming up and I can't make it to that. But the fact of the matter is that there's going to be reparations. There's a lot of us that have dead Civil War soldiers in Oakland Cemetery and that wiped out generations of our people. At least their people are still alive. And you also have to realize that it's not so much racism as it is a stereotype that they brought on themselves. I myself went to school where they were called the blackboard jungle. It was in the paper where the black people were beating us up and taking our jewelry and breaking jaws and breaking legs. If you bumped into them and my grandmother got robbed by some black people that even though she was down on the floor, they had to make sure and kick her. So you would think I would be prejudice. But the fact of the matter is I have a biracial grandchildren because she married a good black man. So it's the good black people that need to get after the thugs, which they're outnumbering the good black people. So they need to get after their own kind. Thank you. So we want our reparations also. And they're going to be a lot more than from the black people because our people are dead.

I received this request to submit information about the possibilities of reparations last night so in short notice. I have constructed a few paragraph paraphrasing some on the history, highlights, ideas and positives that would come out of reparations.

Hello, my name is Anthony Gardner and I was born and raised in Saint Paul, MN on Central Ave and Lexington Ave. Both sides of my family on my mothers side (Price) and father's side(Gardner's) were displaced due to the construction of 94. The displacement caused a shock wave through Rondo separating families and causing frustrations, confusion and doubt in the government who approved the decision. We all know the history of Rondo so I won't go into it in depth.

The majority of my family attended Mechanic Arts and Central High School. My grandfather George Snooky Price was a prize fighter coming out of St. Paul. It was George Price, Freda Rozin and my mother Anita Price, Linda and Roxanne. My grandfather worked construction after his fighting career in which he retired. He resided on Iglehart and we still own that home in the family.

My Grandfather Littleton Gardner owned a dry cleaner on Selby Ave. My uncle Leroy Gardner Sr was a pastor at his church which was located on University and Western and he was the first Black man to graduate from Bethel College.

My uncle Leroy Gardner Jr-Gardner, As young man, was a playground basketball legend. As the community lore goes that as a 14-year-old, he Ralph Mitchell (19) and Tommy Miller (19) beat (then) University of Minnesota basketball players Lou Hudson, Don Yates and Archie Clark in a pickup game at St. Paul's Oxford Park. Gardner went on to play for St. Paul Central from 1962 to 1965 and helped take the team to its first state tournament berth in years. He scored 41 points in a region semifinal and 33 points in a consolation title game. He was recruited by legendary coach Kundla and was the first Black man born and raised in Minnesota to receive a full basketball scholarship at the U of M.

So our St. Paul familial history runs deep. My grandma and grandpa Gardner had 12 kids so it made the Gardner's one of the largest families in St. Paul.

How reparations can help. I don't believe reparations can heal the years and years of anger and animosity towards the people who made the decision, but it can provide some comfort in knowing that people will be compensated. I believe compensation will help uplift St. Paul and allows those that truly love my city to invest in it. We have a huge community that is positive, supportive, and innovative. We have great nonprofits supporting youth in our city and we

have new Non-profits such as mine who will do the same by providing an outlet to get out of the city to boat and fish while learning life skills. Reparations in my mind have been due to the black community not only in Saint Paul but the entire country for decades and counting. People who know the real history and not the fictional version of history understand the complexities of generational wealth, health and education that weren't forwarded to blacks in America.

Jimmy Lee, The Loft and Mr. Robinson created a safe haven for all of the youth in the rondo area. Without that type of support, education, and opportunity to play sports would have caused more people to end up in the system.

How reparations will hurt. I see only positives if this is passed.

What types of reparations? Monetary, Tax incentives, Home buyer grants, subsidies. I think monetary would work best because it can allow people to invest in what they need especially during these hard times of inflation, war, recession, fed hikes, disease and everything else that's happening. We know POC are the people struggling the most.

Who should receive reparations? I believe the original families that were upended by the 94 decision and the descendant's of St. Paul families should receive reparations. Those families who were born and raised here in the 1940s to the 1970's. The black families that helped mold and shape St. Paul to what it is now.

Thank you and I hope my 2 cents will be helpful, yet persuasive to provide the necessary reparations to our St. Paul family and community.

Whatever merit there may be to reparations, the issue is best addressed at a larger level of government than the City of St. Paul.

Another: Redlining began as a federal matter and evolved into a bank lending maneuver. The City had no control over either.

If the Council supports a reparations committee it should go on record asking that the issue be addressed at that state and federal levels.
